Legislative Hearing Officer,

I wanted to express my support for License Application for Alchemy 365 LLC (License ID #20170001768). This is a great addition to Highland Park in a great mixed-use building. Reading the letters in opposition, parking should not be the only concern in issuing a business license. Residents are not entitled to the parking directly in front of their house. Our family spends a lot of time in Highland Village and we arrive by transit or bike - as do many people who currently frequent the area. The Finn will only encourage more people to move around the area without a private automobile.

The area is walkable and the business is at the south end of the Cleveland bike lanes and across the street from a NiceRide station. I'd like to urge the city to require ample bike parking racks (preferably plain lollipop style, not the branded Highland racks). Providing safe bike parking encourages patrons to bike to this location which will have the added benefit of relieving some of the parking and traffic concerns. I'd also like to echo the call for more clearly marked crosswalks with better signage to increase pedestrian safety.
