BWC video footage available (M. Noesen/ B. Moody) I did not review my video footage prior to writing this report.

On 04/05/2018 at 2135 hours, we Squad 370T (M. Noesen/ B. Moody) were assigned to perform a Proactive Police Visit to 1626 White bear Ave (Bamboo Hut), due to multiple incidents at the business.

When we arrived we walked through Bamboo Hut and observed people eating and people at the bar singing Karaoke. Nothing suspicious to report at this time.

On our way out of the restaurant we came in contact with TOUBEE LEE (DOB: 05/26/1988). LEE appeared to be under the influence of alcohol and was possibly over served. Lee said that he had been drinking inside the restaurant. LEE was acting disorderly by actively holding the exterior doors shut as customers were trying to enter.

I informed an employee of the restaurant of LEE's behavior, who asked if LEE could be removed from the restaurant. I directed LEE to leave the premises and he left under his own power and without incident.
