Ms. Dang and Mr. Nguyen,

According to the St. Paul Legislative Code, under Chapters 33, 43 and 45, your parents are NOT allowed to sell the property until the building is in compliance. It will be illegal to sell a Category 3, Registered Vacant Building. Please note that if the bond and proof of financing is not submitted by end of tomorrow, Ms. Moermond will ask the Council to order the building be removed within 15 days with no option for repair and will not go forward to have the matter layover.

You may want to attend the May 4<sup>th</sup> public hearing at 5:30 p.m. in Rm 300 Council Chambers.

Hi Mai Vang,

I am Linh Dang, who is the daughter of the owner of the property. I would like to clarify couple points and would like your helps for the steps in contesting the recommendation of demolishing the property because we would like to repair. It seems that there was a miscommunication in the process:

1) Based on my conversation with Bob Fluegel, who was attending the first hearing on my behalf on February 10th, he confirmed that we need to make a security deposit (\$5000.00) and a plan to repair the property before the hearing on March 4th. I believed the repairing plan has been submitted by Bob Fluegel on February 24th and we planned to make the security deposit this Friday the 27. However, I am still waiting for the code compliance inspection report, per the person who processed my application, a deposit is not required until the report is received by us. At this point I still don't have the report. Please advise on when the security deposit is needed in order to proceed with the repairing plan.

2) Regarding to the hearing on February 24th, I called and spoke to you (Mai Vang) on February 18 to cancel the hearing because Bob was able to attend the first hearing and obtain the action plan. Also, I informed you that if the hearing on the 24 was needed, then you would call to let me know. However I did not receive any call which I assumed everything is good. So, the hearing on the 24th was the backup plan if we can't attend the fist hearing on February 10th.

Please let me know what am I missing in the process and as why the recommendation of demolishing the property in the letter you sent today has been made?

Thanks for your help and I would like to talk to someone from your office to clear up the confusion to prepare for the next steps.
