Dear Applicant:

Our review of your application for a license is in process. Notification has been sent to the community organization and neighbors for the area in which you intend to operate giving them until **Friday, January 11, 2019** to voice any objections to your license application. If no objections are received, and you have satisfied the petition of support requirement referenced below and returned a signed license condition affidavit, DSI will forward your application to the City Council for review. If approved by the Council, your license could be issued (pending completion of any unmet requirements).

If objections are received a hearing will be scheduled before a legislative hearing officer. You will receive notice of the time, place and date of the scheduled hearing from the Legislative Hearing Officer. At that hearing, the hearing officer will take testimony from all interested persons and will make a recommendation to the City Council as to whether the license(s) should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny this license application.

Requirements including, but not necessarily limited to the following must be met prior to the issuance of your licenses:

- Sign and return one copy of the enclosed license condition affidavit acknowledging the conditions that will be placed on your license(s). A return envelope has been included for your convenience.
- Obtain DSI Zoning Division Site Plan Review approval. You may contact Tia Anderson, DSI Zoning Division, at 651-266-9086 with questions about the Site Plan Review process and what required information must be submitted to make application/complete the review process.
- Obtain a Sewer Availability Charge (SAC) determination from the Metropolitan Council Environmental Services (MCES) for the addition of outdoor private property patio seating. Information about the SAC program may be found at the following website <http://www.metrocouncil.org/Wastewater-Water/Funding-Finance/Rates-Charges/Sewer-Availability-Charge.aspx> Payment of any SAC fee owed would be submitted to DSI via issuance of a Building Permit prior to final license approval.
- Obtain all necessary building and/or trade permits related to any work associated with the establishment of this use, and all required inspection approval(s) related to these permit(s). Only licensed trade contractors authorized to perform work in that trade (e.g., plumbing, electrical, ventilation, etc.) may obtain permit(s) and/or perform work in such trade.

- Complete the petition of support requirements. DSI has determined you obtained thirty-five (35) out of a possible eighty-nine (89) supportive signatures, or in other words thirty-nine percent (39%) support. Enclosed please find a list of properties highlighted in pink that you failed to obtain supportive signatures from. You may satisfy the petition requirements by completing one of the following options:

Option #1:

- Submit additional supportive signatures from owners of all private residences, dwelling and apartment houses demonstrating you have obtained at least ninety (90) percent of the possible supportive signatures for each of the license types.

Option #2:

- Submit additional supportive signatures from owners of all private residences, dwellings and apartment houses demonstrating you have obtained at least sixty (60) percent of the possible supportive signatures for each of the license types **and**;
- Submit a written explanation which clearly demonstrates that you made a good faith effort to fulfill all petition requirements.

Option #3 (for a petition with less than 60% support):

- Submit a detailed written explanation which clearly demonstrates that you made a good faith effort to fulfill all petition requirements **and**;
- Submit in writing how you believe the results of the petition attempt showed a generally favorable disposition from the surrounding community toward the proposed extension of liquor service to the outdoor private patio seating area. Please note, DSI also recommends you submit additional supportive signatures since it will help demonstrate favorable surrounding community support to the City Council when they review this application.
