 04/26/2011 Arnellia called they didn't get the letter until today due to the work on University. Something is broke and Jerry is working on it and will have it by Mon. 5/2/11KS
 04/15/2011 Letter sent requesting video, ban list, and security list. Due by cob on 04/21/2011. CAR
 04/07/2011 DSI (KS,CAR), SPPD(Winger, Schoen, Arnold, and Axtell) and CAO (Palmer) met with Arnellia and Jerry regarding a police report(CN11-061-056) that indicates a disturbance outside of the bar on 03/30/11where a bottle or glass was thrown at a police vehicle.Event was a birthday party that became an open mike night.
