To whom it may concern,

The City of Saint Paul launched the Rental Rehabilitation Loan Program in 2017 to provide capital improvement financing to landlords providing local, naturally occurring affordable housing. Staff in the Department of Planning and Economic Development have processed several applications for Rental Rehabilitation loans and the application process typically lasts, at least, several weeks.

The length of the application process is the result of two major factors:

- The application consists of over 16 separate components that 1.) collectively determine an applicant's reliability as borrower.
- The application requires landlords to work with, at least, two 2.) contractors to determine the cost and extent of rehabilitation work that is needed, which may take weeks to coordinate.

In December of 2018 Charlnitta M. Ellis began to submit parts of her Rental Rehabilitation loan application for the property located at 801 Aurora Avenue. By Friday December 28, 2018 Ms. Ellis had completed and submitted over half of the documentation required by the application checklist including her payment of a \$50.00 non-refundable application

If you have questions about Ms. Ellis's Rental Rehab application, I'd be glad to answer any that I am, legally, allowed to.
