- Service quality is best controlled when consumers have choice, and reducing/eliminating that choice tempts acquiescence among suppliers.
- The published rates would provide little if any savings versus my current bill, and may create greater inconvenience.
- Reducing the number of trucks is a silly argument given the few trash hauling trucks in relation to the total number of vehicles on our streets; there are more FedEx, UPS, USPS vehicles trolling each day than the trash trucks that come only once a week, yet we hear no one complaints about that.

Dear St. Paul Council:

I am writing to share my thoughts regarding the Coordinated Garbage Collection proposal. While I am generally in support of the proposal since it will decrease the wear and tear on alleys, hopefully eliminate illegal garbage dumping, and help limit the impact on our environment, I do have a few concerns.

1. As was discovered when recycling changed to alley pick-up from curbside, it is difficult for trucks to get through the alleys. This is a direct result of residents being expected to pay for and coordinate this task instead of the city. From my own personal experience, I know that only a few people in my neighborhood contribute to this mandatory

task. Much like illegal dumping, it is inequitable! There must be, along with this proposal, some way to guarantee that the alleys are cleared and ALL citizens contribute to this being done. Perhaps it is paid using the \$52 administrative fee or added to the tax rolls. If city crews aren't able to complete this work, then consider having the garbage haulers do so for additional compensation. Nevertheless, this must be addressed!

2. The rates in the proposal appear to be out of line with what they should be given that the majority of citizens will be mandated to participate in this plan. My current trash hauler normally charges \$28/month for a 65 gallon can. Since my neighborhood block met and the majority elected to contract with a specific company, we have received a discount, so I pay only \$18/month. When I compare this rate to what the City of St. Paul is proposing, it is a losing proposition. I would be expected to pay \$29.76/month. Even if I deduct the approximately \$2/month charge to cover the bulk items, I am paying \$27.76/month plus an annual \$52 administrative fee (\$406.82 total). This is significantly more than the \$216/annually that I expend now with my fellow neighbors. I encourage you to negotiate a better rate much as we have done!
3. Finally, I'm not convinced that it is beneficial to automatically charge participants for bulk item removal. We should have the option to elect it or not just like yard waste. Some people in the neighborhood choose to take it to the county compost sites and others prefer their hauler to remove it (periodically or seasonally). Having lived in St. Paul 10 years, I rarely need to dispose of mattresses, appliances, electronics, or furniture. The few times that I have done so, I have either given them away, donated them to local community non-profits, or transported them to businesses that will recycle them (e.g Best Buy or OfficeMax). I can also take my items periodically to the bulk items disposal events held by the county. There is no point to my paying \$23.88/annually for a service that I will rarely or never utilize. Since the garbage collector will be required to handle billing, residents could contact their hauler to request the service—as I am able to do with my present trash collector should I require their service. Please reconsider this aspect of the proposal.

Thank you in advance for considering my concerns regarding this proposal. I look forward to reading about the outcome in the next few days.

Good afternoon!

My name is David Lueth and I've been a resident of the Hamline-Midway and Como neighborhoods for over a decade. I recently found out about a new proposed garbage hauling system; I would like to express my concerns about the new garbage hauling plan.

I'm very concerned about this garbage hauling system. Although I do agree that reducing the number of garbage trucks going down streets and alleys is a good thing, the costs outweigh the benefits. In particular, the pricing structure disproportionately affects those who can least afford it. I'm a college writing tutor who bought a house in the Midway five years ago (I've lived in the area since attending Hamline in '05-08); I make about \$22,000/year, and the cheapest option under this plan will increase my rates while providing me with less frequent pick-ups than I currently have (not to mention that my current hauler, Pete's, has fantastic customer service, something I am concerned I will lose if I am assigned a different hauler). And I know there are many in this city for whom money is much tighter than it is for me. Although there are likely good ways to reduce street wear, Saint Paul should stick to options that do not penalize low-income residents with higher rates.

A lesser but still valid issue for me is that it also penalizes households that strive to reduce their waste.

And third, although it is not at all clear to me how this will play out, I am concerned that it will impede small businesses, such as my current garbage hauler, Pete's, more than larger businesses; I initially had Aspen, but when my rates continually went up I did research and switched to Pete's. Now I will not have that option. Although I am not entirely opposed to reducing citizen choice for good cause, I am not convinced that this system is a good cause.

Please consider how this new plan will affect the more vulnerable and low-income residents of our beloved capitol city.

I am writing this in response to the Pioneer Press article of the proposed costs to each homeowner. This will double my costs. I live in a duplexed condo. We each have our own unit in one building. We share a 60 gallon container and the year cost to both of us is \$340 which is \$170 each. When the recycling was presented, we wrote to Kris Hageman/Anne Hunt to say we had NO ROOM to put one, let alone two containers. Finally, the city picked up one( I am sure we are being assessed for both in some fashion) and then got a smaller container. I recycle everything and usually we fill it every one-two weeks. Now, it seems, because we have two addresses, that there will be two containers which we definitely have NO room for and it will cost even for the every two week collection \$300 a year for one family. That is approximately double what I pay now. I hope there is information or a platform for multi dwelling situations that do NOT need more than one container. Alleys like ours have very little room for all these carts. IN the winter our recycling cart is in the backyard.

I am not sure if there will be a response to this query by you or sometimes, usually, your staff, but hope that you do read this and pass along so that all situations are taken into account.

I am sorry that I am becoming a pest. I recently received a notice in the form of a post card survey regarding a city wide, area specific, trash pickup proposal. I see from the news that the decision is yet to be made. Not unlike the alarm license proposal I feel this action would force all residents to be put into the same fee paying basket once again. Even in that, I am allowed to chose my own alarm vender. This is not so with the proposed trash pickup.

As you may remember I have been a resident in my St. Paul home for 47 years. I have seen many changes come and go. The change that usually causes huge problems is removing the power of free choice and competition from the market place. A prime example of this is cable TV. I remember that cable TV was touted as commercial free pay TV. Obviously that did not happen. What did happen was area specific monopolies that allow cable companies to totally control a market place, where they are allowed to raise prices at will, either outright or with hidden charges that the average person can not even detect. Recently, CenturyLink was caught in some billing shenanigans.

At one time the city picked up our trash. Perhaps you should see why that was discontinued.

Specific vender trash pickup would not only create area trash monopolies but also, a one size fits all, pricing structure. We have only two people living in my home and being retired we eat out a lot and have very little trash. What I see in this program is the multiple dwelling across the street getting a break on trash pickup and, from what I see in the news, is my trash pick up costing me an extra \$150-\$200 per year.

What I also see happening is the loss of the personal relationship that we have with the trash hauler that we have had for many years. I am not sure who the 15 trash haulers that have signed onto this proposal are, but I am sure that I didn't chose them. Being at the mercy area specific trash haulers would make us just another insignificant number, with no recourse available. Small business and competition is the backbone of our country.

Another consideration is that this would not only affect homeowners but would have a devastating effect on the many independent small haulers around our city.

Please vote no on this proposal. I believe it would be harmful to our city residents as well as small business. I want a voice in what I am buying.

Dear Mr. Tolbert,

We have been following the progress of the proposed trash hauling agreement over the past couple of years. We had attempted to organize all our alley neighbors to agree on one hauler to reduce alley traffic. Some changed. Some had two year contracts (but planned change once the contract expired) and some were loyal to their present hauler. So we did not get to a single hauler. We have 7 in our alley now.

We still disagree with the City taking charge of the hauling industry:

Here is what we see:

The main problems as we see them:

1. Many trucks driving the alleys (6-8 seems common). Bad for several reasons.
2. Some citizens were dumping garbage and tossing large items in other persons' yards rather than hire a regular hauler.

3. Uneven charges between haulers.

The city's solution might resolve the above issues, but create more:

1. Cost burden: We are retired and struggle under ever-rising property taxes. Under the City's proposal, we will pay an additional cost for hauling of \$101.68 per year (increased monthly fee, plus the City's admin/maint. fee).

This on top of likely property tax increases.

2. Business burden: This hurts small family owned hauling businesses who can no longer expand their client base. The hauler we use gave us great service for 25 years and kept their fee lower than any other and used smaller trucks. Our neighbors were waiting for their current contracts to expire so they could switch to Pete's for these reasons. But now that is precluded.

3. A tax: While we agree all citizens should have a trash service (to reduce the dumping issue), those who live in areas most oppressed by this problem are low or no income. I doubt they will be able to pay for the service. I guess it will be added to their property tax. Or will this be placed on the citizens at large? Another tax? Landlords increasing already unbearable rents?

4. Unused service: Some of us never need to have large items hauled. But, regardless, we would be paying for that extra service.

4. Dumping: Will it really stop those who have the habit of dumping on someone else?

Some suggestions:

1. Cancel all hauler contracts effective the end of this year. This would free up property owners (who are locked in a contract) to choose a new hauler.

2 Give all property owners notice that they have one year (by Dec 31, 2018 - or an earlier date if that is feasible) within which to select one hauler for their one-block alley. If 2/3rds of the owners (that abut the alley one block long) agree on a hauler, that hauler is chosen. If at least 2/3rds do not agree, then the city assigns a hauler to that alley. This would result in only one truck going down all one-block stretch of alley.

3. Haulers may advertise to the property owners, attempting to gain the business. If they do so, and if a hauler is chosen by the alley property owners, that hauler must keep that rate for 5 years. No increases except for fees and taxes that are imposed on the hauler.

4. The city should publish (in the newspaper and on-line) the fees of all the current haulers. Then the property owners can choose a hauler based upon the service and the fees they charge. Again, if haulers advertise, they must also offer a 5-year-long fixed rate.

5. Any property owner who does not pay the chosen hauler should have his/her property assessed at the hauler's highest fee, plus a substantial penalty for causing the city to apply the assessment and process payment to the hauler.

I know that a citywide trash collection program is inevitable, but as a constituent I do want to register my opposition to it. St Paul is a big city, too big for centralized garbage collection like Maplewood. I appreciate the current system where I am able to choose a hauler. While it may seem obviously inefficient to have a multitude of garbage haulers running down the same streets of Saint Paul it unleashes competition amongst these haulers for my dollar, it gives me the freedom to switch haulers at my discretion if I am unsatisfied with any part of their service (which I have done), it lets 'blocks' of residents get together and select a particular carrier and get a better rate, it allows neighbors to share a trash container to cut costs (this is especially valuable since recycling was changed to take about 80% of what used to be my garbage). This last saving tactic will disappear as you are about to force all addresses to pay for collection.

I do not need and will not use the 3 'free' bulky items per year, we have multiple neighborhood/city collection weekends to dispose of those products that are run by volunteers, my Christmas tree is taken to the city compost which I am already paying taxes to run.

Kris Hageman from Public works department has said she is pleased that the 'rates under the new program will provide an incentive for people to recycle more and throw away less', sorry but this incentive is already in play as I get the smallest garbage container available from my selected carrier due to the recycling. She should therefore already be pleased.

The extremely LAME argument 'providing more consistent pricing' is shameful. Why is consistent better if it removes my right to change haulers and receive a better price, that is my job as a consumer, I do not need you 'watching' out for me, it is my responsibility and if I choose not to exercise it, it is on me.

Wait till the complaints come in next summer when people on a 2 week collection have rotting chicken parts, ripe dog excrement and other putrid offensive odors feeding maggots and wafting down the alley on a hot summer night... of course then maybe the council can get together and create another new law, maybe we could hire city deodorizers.

You have already informed me that my taxes may jump as much as 20% due to the courts removing nonprofits from the street maintenance fee collection. I do not want to give you another \$5 a month (cart maintenance) for something I do not need or want while you force a hauler on me with my voice

administratively silenced and I am forced to pay more for a service I currently have, that I chose, and am very happy with.

Leave it alone, PLEASE.

I am sorry that I am becoming a pest. I recently received a notice in the form of a post card survey regarding a city wide, area specific, trash pickup proposal. I see from the news that the decision is yet to be made. Not unlike the alarm license proposal I feel this action would force all residents to be put into the same fee paying basket once again. Even in that, I am allowed to chose my own alarm vender. This is not so with the proposed trash pickup.

As you may remember I have been a resident in my St. Paul home for 47 years. I have seen many changes come and go. The change that usually causes huge problems is removing the power of free choice and competition from the market place. A prime example of this is cable TV. I remember that cable TV was touted as commercial free pay TV. Obviously that did not happen. What did happen was area specific monopolies that allow cable companies to totally control a market place, where they are allowed to raise prices at will, either outright or with hidden charges that the average person can not even detect. Recently, CenturyLink was caught in some billing shenanigans.

At one time the city picked up our trash. Perhaps you should see why that was discontinued.

Specific vender trash pickup would not only create area trash monopolies but also, a one size fits all, pricing structure. Dear Councilman Tolbert,

At least 4 "issues" within the City's proposed City-administered trash program are directly offensive and financially predatory to thousands of St. Paul residents.

1. The 52 dollar annual administrative fee proposed for the proposed City Trash Collection Program is a predatory fee. If that administrative fee proposed was to have been set at a suggested 10 or 20 dollars a year, it would not have been an offensive fee amount. It strikes me as yet another "way" the City is predatory in its attitude to "make money" for its coffers. In contrast, if the City spent more time ticketing aggressive speeders on Ayd Mill Road, a great amount of revenue for the City could be made. I never see any speeders being ticketed on Ayd Mill. That lack of ticketing is an example of the City's disregard for earning revenue in a proper method. Note/ If Ayd Mill Road is not a road "owned" by the City, my point is still valid. Also, the recent issue of 5,000 alarms a year, and the low fees having been charged to "alarm - holders", is yet another example of the City's disregard for properly managing its expenses. The existing "alarm fee" of 28 dollars, etc, have been excessively low for years and years, thereby straining the budgets of City services. Even the low amount of suggested Fee increases are too low an amount, in my opinion.

2. I currently pay my neighbor 10 dollars a month to share garbage collection. That's 120 dollars a year. I am a low income resident and this has worked well for me and my neighbor. However, In your suggested "new" program, because of its punitive suggestion to remove the Opt Out option, my annual trash expenses would increase from 120 dollars a year to 22 dollars month x 12 = \$264 plus 52 = \$316, which is a 164 percent Increase annual increase for trash collection imposed upon my poverty level income.

In other words, the reason I receive SNAP nutrition assistance is because my discretionary income is too low to be able to buy enough groceries without SNAP assistance. In other words, the City now wants to suggest that I will need to spend 164 percent more annually just for trash collection. Because the Opt Out Option is being suggested for removal, it shows me the City is hostile to low income residents who live in a home.

3. The fact that the proposed City Trash program suggests removing the Opt Out Option is a predatory strike against low income residents such as myself who need every dollar every month to simply cover basic and ever increasing expenses such as increased heating costs, water bills, increased transportation expenses, increased property taxes. The fact that I can now share trash expenses is a mandatory requirement for managing my low income.

4. I make about 30 to 40 annual trips a year to the compost sites. I also make use of the organic recycling option, which is an incredible hassle. Most of my neighbors are not making use of organic recycling. Note/It was much more convenient to throw food remnants into trash collection. For years, I have also made regular use of the curbside paper / container recycling. Note/ only about 40 percent of my neighbors were making use of curbside recycling.

But now, the City wants to mandate that I increase my expenses by 164 percent a year to pay the City for me to put out 3 grocery size bags of garbage each month.

5. The poverty level of City residents in St. Paul, as per the City Council's awareness last fall, 2016, was at least 25 percent. The poverty level of seniors living in St. Paul is likely much higher than 25 percent. Isn't it peculiar.....Several of your City Council members just spent the last 6 months and more, "studying" "what and how" to "alleviate" poverty of residents of the City. Yet the City seems to not now blink an eye at its "suggested rules" for its proposed Trash program, yet another indication of Mayor Coleman's disregard for poverty, low income families, low income seniors, and overly stressed homeowners.

Please think more clearly about how this City is becoming a money pit of aggression from the City towards its *People*. The suggested Trash Administrative Fee, the discontinuance of the Opt Out Option, and the failure of the City to properly respect how poverty is a very real status is a regrettable lack of regard.

In the meanwhile, Councilmember Tolbert, maybe you could look into why Police presence on Ayd Mill Road is nonexistent, and maybe you could get some Police activity on Ayd Mill Road to properly ticket offensive speeders.

Hi -

I know the city council is meeting today so I'm not sure if this will make it in time for that meeting or not. Either way, please submit it to the record as a voice against the organized trash proposal in St. Paul.

I live in Mac-Groveland. Two years ago our very long time hauler went out of business because he didn't want to deal with the hassles of this upcoming debate about organized trash hauling in St. Paul. We were not at all happy with the company who took over his business:

The pickup service was unreliable, many weeks were missed, the cart was put back directly in front of the garage door and not off to the side where we placed it that morning for pickup, the cart wasn't completely emptied every week, I had to wait on hold for over 15 minutes to file a complaint every time, etc.

We shopped around for a new hauler and found one. What a luxury to be able to switch haulers! The new hauler has been great. I AM NOT looking forward to having zero other options of haulers if there are any issues with my trash collection, billing, etc.

We currently pay **\$19.53/mo** (includes taxes & fees) for a 35 gallon bin picked up weekly. No annual fee. No bulk item pickup. No xmas tree pickup.

If we compare apples to apples with what the Pioneer Press published about the new organized rates in St. Paul:

$\$24.40/\text{mo} + \$4.33/\text{mo}$  (\$52 annual monthly fee divided by 12) = **\$28.73/mo**.

**This is an immediate 3.2% increase to my trash hauling bill each month. Sure, that doesn't sound like much. In one year that calculates out to an increase of \$110.44.**



For the "free" bonus of getting 3 bulk items and a xmas tree hauled away, it's not free. I am happy to haul my xmas tree "for free" to the compost site myself and if we need to throw away bulk items we haul them ourselves and pay a whole lot less than \$110.44 to do so. Please understand it may not seem like a big deal to many folks to organize trash but it is a huge deal to me. Let the tax payers choose who they want to haul their trash, keep rates competitive and keep haulers honest & reliable because as I learned a long time ago in Economics class, a monopoly is the worst thing to happen for cost control and good customer service. Greetings.

Please accept my email into the record associated with the July 19, 2017 Public Hearing Resolution 17-203 on Organized Collection Options.

While I agree there may be some merits to an organized collection program in the City of Saint Paul the current proposal does not meet what I would agree is sound public policy. Personally I will see a rate and fee increase that will total more than \$160 annually. \$52 of this amount will go to the city to fund 4 new and unnecessary employees and an ongoing City obligation of over \$700K annually. The remaining dollars will go for the purchase of new carts. We already have carts, carts I have paid for already via my fees to my selected hauler.

Undoubtedly there will be some that default on their fees to haulers. Please share with us how the city intends on compensating haulers for unpaid accounts, what amount is estimated to accrue on an annual basis and the source of those funds.

It has been said that this is the last chance for the haulers to proceed with a plan that will not result in an outcome where an RFP will be issued which may result in a single, national company, providing service city wide where 14 small businesses may lose their livelihood. This threat to these businesses is wrong. After decades of responsibly serving customers, negotiating rates and carrying out responsible waste stream practices these small businesses, the employees and the customers do not deserve being told that they can no longer do business in St. Paul.

In my opinion, the city has failed, to date, despite paying a contractor (May 2, 2016 Foth Infrastructure Contract #881) over \$300,000 to manage this process and establish a communications plan to city residents, to qualify or quantify the cost / benefit of implementing this plan. There are anecdotal preferences both for and against but when taxpayers are asked to contribute more the burden should lie with the city to justify the cost. I have not seen a benefit analysis that supports your initiative.

To me, numbers presented for illegal dumping (\$250,000) do not justify creation of a new city program costing \$850-700K per year plus another \$6-8 Million dollars for new plastic carts. Can you commit that once implemented the \$52 annual fee will never go away after the carts are paid off? I understand you cannot commit to the actions of future councils but I am confident you probably don't believe it will ever go away.

You know, there are a lot of businesses that frequent our neighborhoods, distributors driving trucks, shipping / receiving companies, restaurant delivery and others. As it should be, none of these other users of our infrastructure are faced with the city telling them where and how they can do business. Our overall "traffic" will see minute reductions by forcing one industry to experience over-regulation all the while forcing an increase in cost to residents for a negligible return. It does not make sense to target one industry.

You're creating a new tax at a time the city budget is stretched razor thin. You could justify to me reasons why we need to invest in parks, libraries, poverty reduction and public safety. Instead you're choosing to invest in in four new staff and 78,000 plastic carts we already have.

This proposal is not ready for prime time and simply unnecessary. To me the cost of this proposal does not substantively change the livability of this city in a meaningful way. Thank you,

Dear Council Member Tolbert,

I don't have strong feelings on organized trash collection. As an environmentalist, I support it. As a homeowner, I'm concerned that the price will go up and selection options and quality will go down. If you haven't already, I suggest you allow people to opt out. An opt-out provision will allow neighbors who produce very little trash (like us) to share a can and save some money. If someone's house is vacant for many months, they could also cancel their garbage service for the period when they're away and save money. Allowing people to opt out would also soften the psychological transition. Reading the Villager and other comments, more conservative/anti-government people complain that organized trash hauling would become just another mandatory fee or tax, like their water bill or right-of-way assessments ...back when we had them (sigh). Also, I've become aware that a few folks in my neighborhood haul their own trash. An opt out would allow them to keep doing that.
