In support:

Deb Loch (2139 Fairmount Avenue) spoke about the challenges faced and benefits brought by small breweries such as the one she and her partner were starting. She said it was time that St. Paul joined other jurisdictions in expanding options for taprooms.

Dane Breimhorst (225 Richmond Street) said he and his business partner were planning to open the Midwest's first gluten-free brewery. He said a taproom would generate \$30,000 to \$40,000 a year in taxable revenue and would provide additional employment opportunities.

Matt Hauch (3921 E. 26th Street), Chief Operating Officer for Fair State Brewing Cooperative, spoke about how small breweries in Minneapolis were becoming important parts of their communities, and could do the same in Lowertown and along the Central Corridor.

Councilmember Stark moved to close the public hearing. Yeas - 7 Nays - 0

Councilmember Thune asked whether the rules applying to other bars would also apply in tap rooms. Councilmember Stark said the rules relating to the serving of alcohol would apply in taprooms. Councilmember Thune asked about parking requirements. Councilmember Stark said the requirements would depend on the neighborhood. He noted that there were no parking requirements for businesses along the Central Corridor.

Councilmember Stark expressed appreciation for people who came to testify, and said he felt the change would make it easier for this new kind of small brewery to open up.

Final Order approving the sidewalk improvements in the west Midway area of Ward 4. (File No. S1204, Asmt No. 125305)

Hilary Holmes, Planning and Economic Development (PED), gave a brief staff report. She said the infill would provide sidewalk access to the Central Corridor, and the program would pay for half the cost of the sidewalks. She said there was a pre-hearing meeting in the neighborhood, and follow-up one-on-one meetings to get feedback.

Councilmember Stark said based on feedback from community meetings, he wanted to remove from the program the segment on Ellis Street, which was likely to require work within five years anyway, and the segment on Carlton Street. He said the business at that address was using the area for pull-in parking and he wanted to allow time for them to find alternative parking.

In opposition:

Mark Rancone (682 Goodrich), manager of two commercial properties on Transfer Road, said he did not feel there was enough time between the community meeting and the Council vote. He said Transfer Road would be truck-centered and not pedestrian-friendly for the foreseeable future, and having a sidewalk would not increase property values. He said adding a sidewalk would result in the removal of mature trees and require maintenance by the property owners. He said CIB money was not a gift, and he asked that the Council vote against the project, at least for Transfer Road.

Wayne Robedaux, property owner at 842 Vandalia, questioned being charged \$8,000 or \$16,000 for a sidewalk that would run along the side of the building. He said snow was pushed against the building in the winter and trucks drove along the boulevard in the summer, and there was no need for a sidewalk.

Chad Commers (1870 Highland Parkway) said he worked with Mr. Rancone and handled rental of the properties. He said he had been at the properties over the past couple of days and not seen any pedestrian traffic. He echoed Mr. Rancone's concerns about added maintenance.

Councilmember Stark said Kari Rihm from Rihm Trucking had not been able to attend the the meeting but had submitted a letter of opposition to the segment on Transfer Road.

In support:

Amy Sparks (890 Cromwell Avenue), Executive Director for the District 12 Community Council, said it was a complex issue with competing needs in an industrial area close to the Light Rail line. She acknowledged the need for more conversation and said Territorial would be problematic as well. She said they wanted more sidewalks but there was also a desire to keep the industrial area strong. She said the board had voted on the plan after extensive conversation, and the majority were in favor of the plan as originally proposed.

Stephen Maste (2350 Bayless Place) District 12 Community Council member and property owner at 856 Raymond Avenue, said the segments chosen for inclusion were the easiest ones with the least disruption. He said it was important to be cognizant of public safety around the Central Corridor, and stressed the importance of connections to the Central Corridor.

Councilmember Stark moved to close the public hearing. Yeas - 6 Nays - 0

Councilmember Stark said the goal was to create pathways for pedestrians and not to put sidewalks everywhere; he explained the rationale behind some of the choices made. He said new sidewalk was always controversial and he didn't feel more time would have led to a different program. He thanked those who had come to testify, and said it was a difficult decision but he felt the program met a demonstrated need. He moved approval of the resolution as amended.

LEGISLATIVE HEARING ITEMS REQUIRING DISCUSSION

- 34** [RLH VO 13-11](#) Appeal of Bill Bernier to a Fire Inspection Correction Notice (includes condemnation of Third Unit) at 776 AURORA AVENUE.

Legislative Hearing Officer Marcia Moermond said the appeal was of three items on the orders relating to the use of the property as an illegal triplex. She said there were three mailboxes at the property, there'd been a Craigslist ad placed for the third floor attic space, and there were deadbolts between the levels. She said the appellant had signed a covenant as part of the third floor renovation stating that the property would be used a duplex, but he claimed he'd signed it under duress when pulling the building permit.

Appellant Bill Bernier said he'd spent \$25,000 on the attic, and all of the work had been done under permit and been finalled. He said the ad on Craigslist calling the unit a third floor unit was an error. He said he was allowed to have the space occupied, and people living in the upper two units didn't need to be related for the two floors to be considered a single unit. He referred to language in the code about unrelated adults, and said it was a misperception that it was a triplex. He said he could have as many mailboxes as he wanted. He said the people on the third level had a right to secure their belongings and there was no statute limiting the placement of locks. He said the third floor tenants had moved out when the unit was placarded.

Councilmember Brendmoen asked whether the third floor had a sink, refrigerator, or stove. Mr. Bernier said there was a sink in the bathroom, but there was no stove or refrigerator. He said there were two refrigerators on the second level. He said he was making the highest and best use of the property, and there was one water heater and one furnace, but separate breaker boxes. He reiterated that the work on the third floor was done under permit and inspected, and if the third floor was illegal the inspectors should have pointed it out.

Councilmember Carter moved to close the public hearing. Yeas - 6 Nays - 0

Councilmember Carter confirmed with Ms. Moermond that there were unrelated adults on the 2nd and 3rd levels, there were locks between the two levels, and there were three mailboxes, and separate breaker boxes. He asked whether deadbolt locks between the levels were permissible if it was all one unit. Ms. Moermond said it depended on how the lock affected fire egress. She said in this case the type of lock present was one factor cited by inspectors as evidence the property was being used as a triplex. She said the current issue was the condemnation due to violation of the fire code, and there were separate zoning and building code issues.

Council President Lantry said the property needed to be made to comply with standards for a duplex in a way that was not skirting the intent of the law, and inspections staff had laid out those requirements.

Councilmember Carter agreed, and said the requirements for compliance were pretty straightforward. He moved to adopt deny the appeal.

Legislative Hearing Officer Marcia Moermond said the appeal was of a tax assessment for a property clean-up. She said there had not been a Legislative Hearing because the appellant had exhausted the three opportunities to reschedule, so she did not have a formal recommendation for the Council. She reviewed the online history, and recommended approval based on that record.

Appellant Trent Peterson, said he and a business partner owned a number of rental properties and were trying to provide housing for people who don't have it. He apologized for missing the Legislative Hearing. He said the property was next to a Centurylink dumpster that attracted dumping, and Centurylink was moving rubbish to his property. He said the lease with his tenants stated that it was their responsibility to forward notices, and that wasn't done in this case. He said they also weren't notified by the tenants of the dumping problem. He said he was not asking for the fine to be eliminated, but was asking for the extra charges to be removed. He said he was appearing on behalf of the tenant who would have to pay the assessment. He said the tenant had six children.

Council President Lantry moved to close the public hearing. Yeas - 6 Nays - 0

Council President Lantry said mail should be sent to the property owner, and there should be someone responsible when the owner is away. She said Mr. Peterson should be talking to Centurylink. She said he received notice and should have done the work, and should absorb the assessment as a cost of doing business rather than passing it along to the tenants. She moved to approve the assessment.
