**As owner or person(s) responsible for: 1339 SHERBURNE AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.**

- Remove improperly stored or accumulated refuse including: garbage, rubbish, broken table, appliances, vehicle parts, scrap wood, metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from the alleyway.**
- Cut and remove tall grass, weeds and rank plant growth.**
- Remove and properly dispose of all animal feces from yard areas.**

If you do not correct the nuisance or file an appeal before **April 26, 2011**, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

**\*WARNING** Code inspection and enforcement trips cost the taxpayers money.
