NOTICE OF PUBLIC HEARING
Mississippi Market, 740 7th Street East
Construction of a Natural Foods Co-op Store

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request.

Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 740 7th Street East

Noise Source: Mississippi Market has requested a sound level variance in order to excavate and construct a Mississippi Market Natural Foods Co-op Grocery Store at 740 7th Street East. The variance is requested for the noise source of operation from 7:00 a.m. to 6:00 p.m., Monday through Friday, from September 30, 2014 to August 1, 2015. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the Mississippi Market Natural Foods Co-op Grocery Store Excavation and Construction Project at 740 7th Street East, from September 30, 2014 to August 1, 2015. 2) Noise source of operation will be from 7:00 a.m. to 6:00 p.m. Monday through Friday. 3) The Contractors working on the project will use best practicable methods for controlling noise such as, but not limited to, noise blankets, shields or portable sound barriers. Construction activities will be scheduled to minimize noise as much as possible in the late night and early morning hours. Jackhammers, pavement breakers, pile drivers and any similar type of equipment should be fitted with manufacturer's approved exhaust mufflers. 4) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 5) A copy of this sound level variance must be maintained at the event location and be available for review by the City of Saint Paul Police or inspection personnel.
