There is an existing drainage swale on the property which leads to the right of way. You can see it on Google street map. That will soak in (some) water during the growing season. I think it addresses the intent of what needs to happen – discharging on the property. Digging a French drain or retaining feature on the property won't likely work – the soils in the area are listed by NRCS as having moderately slow permeability. The sump would likely exceed the capacity to soak into the soils, necessitating positive drainage relief at the surface.

Happy to discuss this further. Let me know.
