Appeal for 694 Bradley Steet, St Paul

I asked Inspector James Thomas to verify the rear 2nd floor bedroom would be considered legal bedroom. He met me at the property and took measurements of the room. The room square footage was approx. 13x13. The questionable portion is if the ceiling height in 51% of the room was above 7 feet tall. With the measurements he took, he stated that it did not meet the minimum requirement. The measurements were very close so the room could be considered a legal bedroom. Therefore, I am entering this appeal to consider this room a legal bedroom which would give the house 4 legal bedrooms.
