## **NOTICE OF PUBLIC HEARING**

### Twin Cities Walk to Defeat ALS – Lake Phalen Park Sound Level Variance

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Lake Phalen Park

**Noise Source:** The ALS Association Minnesota North Dakota South Dakota Chapter, Twin Cities Walk to Defeat ALS 2016 Event, represented by Jessica Jesswein, Corporate Relations Manager, has requested a sound level variance in order to present a D.J. and announcements at Lake Phalen Park from 8:00 a.m. until 12:00 p.m., with a pre-event sound check at 8:00 a.m. on Saturday, September 17, 2016. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 8:00 a.m. to 12:00 p.m. on Saturday, September 17, 2016. 2. All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the event date.
