Revocation of Fire Certificate of Occupancy and Order to Vacate

1707 ENGLEWOOD AVE

Dear Property Representative:

Your building was inspected on August 11, 2017 for renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

A re-inspection will be made on September 11, 2017 at 2:00 PM or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. Exterior Retaining Walls at Driveway SPLC 34.08(5), 34.32(3) All accessory structures including, but not limited to, detached garages, sheds, retaining walls and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements.
 - -Retaining wall at either side of driveway has deteriorated ties, rotted through and listing toward the driveway.
 - -Per appeal hearing, this order was extended to August 1, 2017.

8/11/17 comment: Has not complied.

8/15/17: PO contacted inspector and inspector reviewed the property with 20 pictures of the property taken. Conferred with Supervisor AJ Neis and issued the revocation letter with comments. West side of driveway has wood structure, unable to determine tiebacks or depth of posts. East side of driveway has retaining wall removed and nothing preventing soil from leaving the site.

- 2. Exterior Roofing SPLC 34.09 (2), 34.33 (1) Provide and maintained the roof weather tight and free from defects.
 - -Shingles are cracked and peeling up at edges.
 - -Per the appeal hearing, this order has been extended to November 1, 2017.
- 3. Interior Unit 1707, Main Floor and Basement SPLC 33.05 Uncertified portions of the building must not be occupied until inspected and approved by this office.-Lower part of unit 1707 must not be occupied until all permits are approved and inspected by this office.
 - 12/29/16: Property has unoccupied area in 1707, main floor of unit and common area in basement, formerly laundry area. Upper level is occupied.
