## NOTICE OF INTENT TO SUSPEND LICENSES

Dear Ms. Coale:

The Department of Safety and Inspections (DSI) will recommend suspension of all licenses held by Coale, Inc. d/b/a Coale's Bar & Grill for the premises located at 719 Dale Street North in Saint Paul. The basis for the recommendation is as follows:

On March 5, 2012, you were sent a letter and <u>RENEWAL INVOICE</u> from the Department of Safety and Inspections stating that the Liquor on Sale 101-180 Seats (Second Half) license fees were past due. You currently owe \$3,539.00 in delinquent license and late fees. You were given until March 26, 2012 to pay the delinquent license and late fees. As of today's date, the fees have not been paid.

At this time, you have three (3) options on how to proceed:

- 1. You can pay \$3,539.00 in delinquent license and late fees. If this is your choice, you should send the payment directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, April 16, 2012. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees will be considered a waiver of the hearing to which you are entitled.
- 2. If you wish to admit the facts but you <u>contest</u> the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by **Monday**, **April 16**, **2012**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your licenses. You will have an opportunity to appear before the Council and make a statement on your own behalf.

3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, April 16, 2012. Information should be directed to the attention of Christine Rozek.

If you have not contacted the Department of Safety and Inspections or me by Monday, April 16, 2012, I will assume that you are not contesting the suspension of your licenses. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
