**Event:** Cozy Days One and Two, Customer Appreciation Event and Mexican Independence Celebration

**Description of Variance:**

**Location:** Cozy Cantina, 202 Cesar Chavez Street Parking Lot

**Noise Source:** Cozy Cantina has applied for a sound level variance, at a requested sound level limit of 80 decibels (dBA), with no specified distance in order to provide outdoor DJ and live music at Cozy Cantina, in the parking lot at 202 Cesar Chavez Street on Saturday, August 20, 2016 for a Customer Appreciation Day Event and on September 17, 2016 for a Mexican Independence Day Celebration from 12:00 p.m. to 10:00 p.m., with an event sound check during the hours of the variance. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 12:00 p.m. to 10:00 p.m., with an event sound check during the event for a live band and DJ music outdoors on Saturday, August 20, 2016 and September 17, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Saturday, August 20, 2016 and September 17, 2016.
