NOTICE OF INTENT TO SUSPEND LICENSE

Guy Nelson, Owner Guy Nelson Construction, LLC 3416 - 116th Avenue NW Coon Rapids, MN 55433

Sidewalk Contractor license held by Guy Nelson Construction, LLC d/b/a Guy Nelson Construction, LLC for the City of Saint Paul License ID #20120002112

Dear Mr. Nelson:

The Department of Safety and Inspections (DSI) has recommended suspension of the Sidewalk Contractor license held by Guy Nelson Construction, LLC d/b/a Guy Nelson Construction, LLC for the City of Saint Paul. The basis for the recommendation is as follows:

On March 5, 2013, you were sent a letter and <u>RENEWAL INVOICE</u> from the Department of Safety and Inspections (DSI) stating your Sidewalk Contractor license expired as of November 30, 2012. You currently owe \$250.00 in delinquent license and late fees.

You were also asked to submit the following required information: 1) current certificates of Automotive Public Liability and Non-automotive Public Liability insurance showing the City of Saint Paul as Additional Insured; 2) a current \$5,000.00 Sidewalk Bond and 3) a completed Certificate of Compliance Minnesota Workers' Compensation Law form.

You were given until March 26, 2013, to pay the license and late fees and submit the required information. As of today's date, neither has been received.

In addition to the suspension of your Sidewalk Contractor license, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit the required information in order to maintain your license.

At this time, you have three options on how to proceed:

1. You can pay the delinquent license and late fees and submit the required information. If this is your choice, you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Thursday**, **April 11**, **2013**. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the required information will be considered to be a waiver of the hearing to which you are entitled.

- 2. If you wish to <u>admit</u> the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. I will need to receive your letter by **Thursday**, **April 11**, **2013**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your license and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Thursday**, **April 11**, **2013**. Information should be directed to the attention of Christine Rozek.

If you have not contacted me by Thursday, April 11, 2013, I will assume that you do not contest the suspension of your license and imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
