**Thomas invited you to view a folder on Dropbox:**

*"Greetings Jeff, Rebecca: This is a Dropbox link to the six additional owners' signatures for the outdoor seating permit for Stone Saloon, SBC d/b/a Waldmann that DSI requested I obtain. This brings the owners' count to 30 of the possible 50, or 60%. In addition, following DSI's original instructions, we had initially gathered 21 signatures of residents within the prescribed 300 feet--in addition to the 24 owners' signatures we had initially gathered. These, combined with the six "new" owners' signatures above, means that we now have signatures from a total of 46 of the 50 possible living units DSI tallied within 300 feet. That is 92%. I understand residents are not counted any longer for these purposes, but I hope DSI and the Council will nonetheless take that broad support into consideration as the waiver process and subsequent legislative hearing proceed. Jeff, you should already have my signed license condition affidavit. We have received our SAC determination, and I will reach out to you separately to discuss any credits the City has available to help offset our SAC fees. We sincerely appreciate anything you can do to expedite the issuance of the license. Best regards, Tom Schroeder"*
