## NOTICE OF INTENT TO DENY LICENSE

Tylawn J. Barger 1313 Park Avenue South Minneapolis, MN 55404

Dear Mr. Barger:

The Department of Safety and Inspections will recommend denial of the Pedicab Driver license application submitted by Tylawn J. Barger for the City of Saint Paul. The basis for the recommendation is based on the following information:

On August 20, 2012, you submitted an application for a Pedicab Driver license. The Department of Safety and Inspections (DSI) placed an Administrative Hold on your license application until they received a copy of your State of Wisconsin driving record as required by Saint Paul Legislative Code § 375.5 (b) which states: "Application for a pedicab driver license under this chapter shall be made on forms provided by the department of safety and inspections and shall contain such information as the department may require, including the name, telephone number, date of birth, and all residing addresses within the previous three (3) years of the applicant. If applicant has held a drivers' license in a state other than Minnesota within the three (3) years preceding application, applicant must provide an official copy of their driving record in that state."

As of today's date, DSI has not received your State of Wisconsin driving record.

At this time, you have three options on how to proceed:

1. You can submit a copy of your State of Wisconsin driving record. If this is your choice, you should send the information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **February 4**, 2013. A self-addressed envelope is enclosed for your convenience. Submission of the requested information will be considered to be a waiver of the hearing to which you are entitled.

- 2. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter no later than Monday, February 4, 2013. The matter will then be scheduled before the City Council for a public hearing to determine whether to deny your Pedicab Driver license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. You may withdraw your license application. Send a written statement to that effect to the Department of Safety and Inspections (DSI), 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday, February 4, 2013**. A self-addressed envelope is enclosed for your convenience. Any request for a refund of the license application fee must also be made in writing to the Department of Safety and Inspections.

If you have not contacted me by Monday, February 4, 2013, I will assume that you do not contest the denial of your Pedicab Driver license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
