Hello again David,

I have looked through the properties that you listed during our phone conversation, and I have some initial information for you:

1289 Hartford – This was updated through the City records as “property to be razed” with an effective date for the hauler to be approx. 1/7/19;

1232 Scheffer – This property was updated through the City records as showing as “registered vacant - to be razed” with an effective date of 8/27/19;

1400 Bayard - This was updated through the City records as “property to be razed” with an effective date for the hauler to be approx. 12/10/18;

1663 Eleanor – I don’t show any updates on our end for this property.

I have attached the form that you can submit to me if these properties are still vacant – I would just need 1 form for each property. If you do submit these, then the effective date for billing purposes will be the 1<sup>st</sup> of the month following the submitted date.

I know that you were going to look to see what information had been previously submitted, but I thought that I would at least start my research. Please feel free to reach out to me if you have any additional information that you would like to provide or if you have any other questions.
