NOTICE OF PUBLIC HEARING

Sound Level Variance

Peter and the Wolf-Senior Showcase – Ballet Co. Laboratory

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 2 Wabasha St. – Raspberry Island

Noise Source: Rachel Koep, Managing Director, has requested a sound level variance, for 60 dBA at no specified distance, to present amplified sound with use of a sound system for their Peter and the Wolf Senior Showcase Event on May 22, 2021 at 2 Wabasha St.- Raspberry Island. The variance is requested for the hours of 11:30 a.m. to 12:00 p.m. and 12:30 p.m. to 1:00 p.m. on May 22, 2021 with a pre-event sound check at 11:15 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 11:30 a.m. until 12:00 p.m. and 12:30 p.m. to 1:00 p.m. on May 22, 2021, with a pre-event sound check at 11:15 a.m. for the Peter and the Wolf Senior Showcase Event. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured at 50 feet from all sound sources on May 22, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:30 p.m. on May 22, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits
