**Event:** El Burrito Mercado, Noches Tropicales Thursday Music Series

### **Description of Variance**

**Location:** Events will be located outdoors at the La Placita patio space, 175 Cesar Chavez Street

**Noise Source:** El Burrito Mercado, Milissa Silva- Diaz, President/Owner, has applied for a sound level variance, at a requested sound level of 80 dBA at no specified distance in order to provide live or recorded music outdoors from 5:00 p.m. until 9:00 p.m. at the La Placita patio space at 175 Cesar Chavez Street beginning Thursday, July 20, 2017 and consecutive Thursdays through August 31, 2017 for the Noches Tropicales Music Series. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for live or recorded music from 5:00 p.m. to 9:00 p.m. beginning Thursday, July 20, 2017 and consecutive Thursdays through August 31, 2017. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 80 dBA, as measured at 50 feet from the noise source. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on each event date.

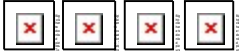
