Mr. Owens,

I am in receipt of your appeal addressing the orders sent to you, dated September 27, 2017, from our Senior Building Inspector. The orders directed you to remove the illegal carport at 237 Bates Ave. due to a variety of reasons:

- A permit is required for work exceeding a value of \$500
- HPC must approval needed for any and all exterior work
- Setback requirements are not conforming to current code
- Structural engineering has not been submitted to our office for this structure

For reasons listed above, your appeal is denied and the structure will need to be removed. Please remove this structure within thirty (30) days of this letter and contact our office when the removal is complete.



The two-car carport has been there for 10 years or more. And this is the first time I have had a complaint and inspectors have been to my rental unit every 3 to 5 years for inspections. I had to remove a maintenance free fence by inspector Virgil Thomas that cost me over \$4,000 and had to replace it with a wooden fence that the inspector ordered me to paint every three years. I am sick and tired of me being singled out. I just want to be left alone and pay my taxes. A troubled tree has been the problem with me getting my car windshield knocked out and my cars totaled this year. The carport has been a big help because of the troubled tree that the City won't move.

Regaurding 237 Bates Ave.

It has been brought to our attension that an carport has been installed onto your property with out obtaing proper permits.

The carport is larger than the 200 squre feet that is allowed without permits and zoning requirements.

This carport is also in a Historic Preservation District which will also require a permit from HPC to install it.

Please remove the carport within 10 days of receipt of this letter.

St. Paul Legislative Code.

Sec. 33.03. Permits—When required.

(a) Building and general construction. No person shall construct, enlarge, alter, repair, move, demolish or change the occupancy of a building or structure without first obtaining a building permit from the building official. Permits for building or general construction are not required for repairs for maintenance only or for minor alterations provided they are not required under the state building code, this chapter or other pertinent provisions of the Saint Paul Legislative Code, and provided the cost of such repairs and minor alterations does not exceed the present market value of five hundred dollars (\$500.00).

You are hereby notified to obtain Permits for the work completed at the above referenced address. Failure to comply may result in the issuance of criminal charges and or a civil lawsuit and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the Building Official at 651-266-8989. An appeal must be made in writing within in 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
