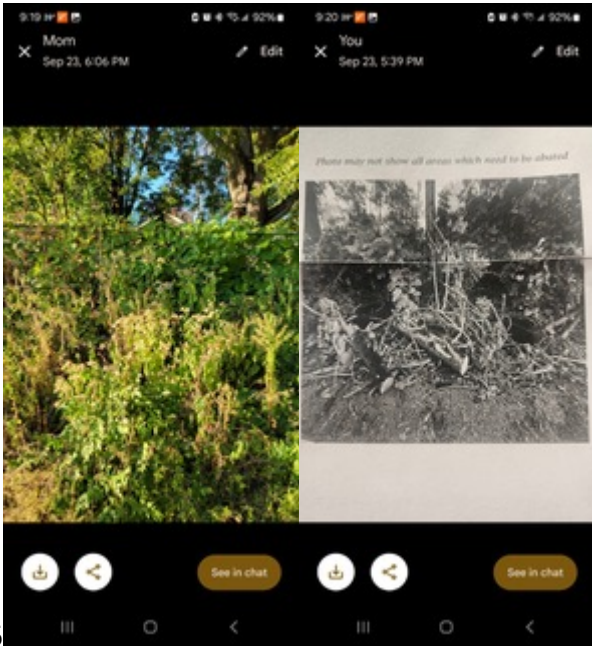
Hello,
