Colleen Mulcahy:

This is to confirm that at the Legislative Hearing on April 23, 2024, Legislative Hearing Officer Marcia Moermond recommended that the City Council:

1. Grant to June 1, 2024 for compliance with the March 28, 2024 Summary Abatement Order; and
2. Grant the following extensions related to the April 19, 2024 Correction Notice:
  - a. grant to May 6, 2024 for compliance with items 4, 6, 12, 15, 16, 19, 20 and 21;
  - b. grant to June 6, 2024 for compliance with 3, 7, 9, 10, 14, 18, and 23;
  - c. grant to August 5, 2024 for compliance with items 2, 8, 11, 13, 17, 22 and 24;
  - d. Note: Item 5 in orders reflects items listed in the March 28, 2024 Summary Abatement Order mentioned above and was given extension to June 1, 2024

**I have attached a spreadsheet documenting the existing orders and corresponding deadlines.**

These matters will go before the City Council at Public Hearing on **Wednesday, May 8, 2024 at 3:30 pm. in room 300 City Hall.** If you are contesting Ms. Moermond's recommendation you may:

1. appear in person (please arrive before 3:30 p.m. and check in with staff outside Council chambers); or
2. **Should you wish to address Council directly but not appear in person, you must register no later than noon on Tuesday, May 7, 2024 here to testify via phone:**

hearings. If you are contesting Ms. Moermond's recommendation from the May 8 hearing, you may appear in person or, **should you wish to address testify by phone you must register by noon on Tuesday June 11 via the link above.**
