- 1. Remove improperly stored or accumulated refuse including: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas. INCLUDING: TV'S, TARP, DOORS, VEHICLE CONSOLE, OTHER REFUSE. ON MARION BOULEVARD. Comply before November 16, 2016

If you do not correct the nuisance or file an appeal before November 16, 2016 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

The telephone number is (651) 266- 8688. You must submit a copy of this Summary Abatement Notice with your appeal application.
