### **Settlement Overview**

- Historic multi-state settlements with pharmaceutical distributors and opioid manufacturers worth over \$46 billion
- Over \$540 million to Minnesota
- \$14M to Saint Paul over 17 years (2022-2038)
- Special Revenue Fund
- Opioid Remediation Parameters
- Reporting and Compliance











### Overdose Tracking Through ODMAP

Since 2019, COAST has utilized ODMAP to track overdose data in St. Paul 24/7 through EMS and SPPD calls. ODMAP also allows for additional data analysis including spike alerts and heat maps.










\* Substances are unconfirmed and not tested, these are substances identified by the individual, EMS, or somebody on the scene.



### **Substance Testing Partnerships**

#### Medical Examiner's Office


- SPPD partners with the Medical Examiners office to test and identify substances involved in fatal overdoses through toxicology reports.
- Since 2020, 343 toxicology reports have been sent to COAST as a part of this partnership
- Of the individuals who tested positive for Fentanyl, 70% tested positive for multiple analogs of fentanyl, and 78% tested positive for multiple substances.



### Drug Surveillance Program

- •SPPD RAP officer submits substances involved in non-criminal cases for testing at MDH.
- •Weekly meetings with MDH and other LE agencies discuss these trends, patterns in use, and new substances of concern
- Since 2020, 40 substances have been tested, analyzed, and informational bulletins released to participating agencies. Included in these were
- •9 substances with new fentanyl analogs
- •2 substances where the individual did not know they were using fentanyl, but it was found in testing
- •8 new substances or cutting agents entering the drug markets

POLY-DRUG USE IN FATAL OVERDOSES 2020-2023





# Harm Reduction through Narcan Use

Narcan was used in 24% of Non-Fatal Overdoses with the majority being administered by bystanders at the scene (43%)

SPPD has administered 505 Narcan doses in 381 separate overdose incidents since 2019

 This is expected to increase with new state statutes that require all officers to carry 2 doses of Narcan while on duty








## Licensed Alcohol and Drug Counselor (LADC)

- As a part of COAST, the Recovery Access Program (RAP) employs the only LADC in Saint Paul that receives outreach-based referrals for those living in the community.
  - Clients are referred from SPPD through COAST, 10+ community-based outreach events that are attended 80% by the LADC weekly, and through partnerships with agencies such as Ramsey County Probation.
- Since March 2021, COAST LADC has had 1,242 Client interactions where;
  - 957 Total Assessments for Substance Use Disorder, Rule 25's, and service assessments were completed
  - 2,130 separate service referrals were completed for a wide range of supports including but not limited to care coordination, treatment, peer support, harm reduction, medical and mental health services, and county services.
  - 44% of LADC clients have met with the COAST LADC more than once since March 2021.

# Investing in Skilled Outreach Workers for Community Stabilization-OUD

Objective: Onboard trained community outreach worker to build trust and address opioid use and violence in high-risk areas.

### **Cultivating Trust:**

- Outreach worker share similar life experiences with the communities they serve
- Focused on building relationships and addressing underlying issues.
- Provide supports to individuals with OUD (e.g., violence, sexual assault, human trafficking, or adverse childhood experiences) and
- Provide family members support to identify and address such trauma
- Act as key mediator between city departments, community stakeholders, and other professionals.

Outcome: Effective disruption of the cycle of opioid-related violence through community engagement.

# Partnerships Parks & Rec, and St. Paul Library

**Objective:** targeted reduction in opioid related violence through a community-first approach.

- Long-term Approach with coordinated, immediate actions for profound, lasting change in tackling Opioid use
- Collective effort and contributions from all corners of the city employees, residents, visitors, and schools—to be part of the solution
- Providing support for and cultivating community space that is responsive by providing outreach and social service connection to meet community needs

## **Cross Collaborative Partnerships: SPPS, SPPD, ONS Working Together to Support Youth and Families**

- Post-pandemic return to school saw a rise in opiate-specific substance use disorders (SUDs), highlighting the need to better understand local opiate use and develop a lasting plan for support and intervention.
- Chief Henry created and delivered training to school nurses, school social workers, educators, and other school staff about opiate use in the city.
- In April 2023, SPPS established an opiate overdose response protocol. School nurses and Security and Emergency Management staff, including 47 School Support Liaisons, were trained to carry and use Naloxone.
- Commander Jeff Stiff, Sergeant Toy Vixayvong, and ASPIRE played key roles in creating a collaborative program for Saint Paul youth. They formed mentorship groups, built trust, and encouraged kids to seek help for SUDs.
- The SPPD also created a cross-collaborative team that includes physicians from the University of Minnesota and support from Wilder, Fairview, Urban Village, and others. The goal is to help families access necessary medical, mental health, and academic support. The program is working, with parents reaching out to request services for their youth.

### 2024 (through 26April)

Calls dispatched as possible overdose – 434
Calls documented as overdose by medics – 505
Calls with Narcan administered – 214
(\*76% reported 'pt not breathing' upon arrival)
