### **Event: Become Co/Red Bull Frozen City 2015 (SLV#3), Locations 4 and 8**

#### **Description of Variance (SLV #3):**

**Locations:** Locations: 4, Ramsey Street Hill, 420 Summit Avenue, Thursday, February 26, 2015 and 8, Cathedral Hill Park, 215 Summit Avenue, Saturday, February 28, 2015

**Noise Source:** Become Co/Red Bull Frozen City Event, represented by Luke Seile, Become Co/Red Bull, Event Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 3 (SLV#3), Location 4, at the Ramsey Street Hill, 420 Summit Avenue on Thursday, February 26, 2015, 9:00 a.m. to 1:00 p.m. and at Location 8, Cathedral Hill Park, 215 Summit Avenue, Saturday, February 28, 2015, from 10:00 a.m. to 5:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #3 Variance, Location 4 shall be for the hours of 9:00 a.m. to 1:00 p.m. on February 26, 2015 and from 10:00 a.m. to 5:00 p.m. on February 28, 2015 at Location 8. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 1:00 p.m. for Location 4 on February 26, 2015 and no later than 5:00 p.m. on Saturday, February 28, 2015.
