Attachment to 3M Aviation appeal of Fire Inspection Correction Notice, filed November 19, 2021

This appeal is specific to number three on both Deficiency Lists for correction notices 24895 and 94906, respectively. Both deficiencies are titled "Southeast Corner" and address missing coverage for a "void space". No other issues are being appealed.

The 3M hangars located at 690 Bayfield Street consist of two separate large Aircraft Hangars, known as 680 and 690. When first built in the early 1940's, the two hangar buildings had an administrative office between them. This building fell into disrepair and was demolished in the late 90's. When the building was demolished, a pocket on each hangar had to be built to accommodate the large sliding doors that open to move aircraft in and out of the hangar(s). This pocket has created the void space in question.

This appeal first is asking the City of Saint Paul to grant a hardship variance for the missing sprinkler coverage in these small void spaces, based upon the following facts:

- They are not intended for human occupancy, passthrough or movement.
- They are not intended or used for storage of any type.
- The area in question is over 50 feet high, but it has a working width of less than 43 inches wide. This makes completely closing off the area from the rest of the hangar to the door pocket significantly dangerous to the safety and health of construction workers. OSHA standards for scaffolding state that when working at height, scaffolding must have a minimum 4:1 width to height ratio or be braced. In this instance, the 4:1 ratio cannot be achieved and supporting braces cannot be set against the moving doors. Additionally, the doors cannot be opened to make more room because, when opened, the doors fill the void and block the void space.
- Extending sprinkler piping, heads and water into this area comes with a freezing risk, as the area is open to the hangar but does not receive any forced air and is in the furthest corner from heat. Pipes will be less than 40 inches from the exterior doors and the void space is uninsulated. Furthermore, the addition of sprinkler piping comes with similar challenges for working at height safely.
- This void space is fully constructed of metal materials, so the walls and ceiling are non-combustible. If fire were to occur in the void, it would have to migrate into an area that has sprinkler coverage to impact the rest of the hangar.
- Aircraft hangars are subject to NFPA 409, which is undergoing a significant revision for 2022. Are we assured this order is in keeping with the updated NFPA 409?


It is our belief that the risk of completing the work asked for in the Fire Inspection Correction Notice outweighs the benefits gained from completing the work in terms of safety.


Secondly, in the event that the hardship variance is not granted, 3M would request a 365 day extension to engineer a solution that meets the Correction Notice and eliminates the risks mentioned above, along with time to complete the needed construction. 3M notes these void spaces have been in place for over 25 years without incident.

Please see the attached photographs showing the challenges of working in this extremely high and narrow area.








BUDG 680 GENERAL UTEW OF AREM

BLDG 680 WIDTH MENSURE From




BLDG 680 Width Measure TO = 42.25 inches



- 2. **Fire Extinguisher Signage** MSFC 906.1, MN Stat. 299F.361 Fire extinguishers Relocate or remove fire extinguisher signs that no longer correspond to the extinguisher locations. Includes in enclosed room at southeast corner and across from lobby.

3. Southeast Corner - MSFC 901.6 - Fire Sprinkler system has missing coverage for area where wall have been opened to the previously sealed void space at southeast corner. Seal the wall to enclose this space or provide approved sprinkler coverage if area is to be left open to main hangar.

corner. Provide a wall to enclose this space or provide approved sprinkler coverage if area is to be left open to main hangar.
