Regarding #1, Egress windows in lower unit bedrooms

Each of the two lower-unit bedrooms has two double-hung windows which can serve for egress. Per the inspector's report, each window has a width opening of 25 inches, and an height opening of 22 inches. The windows themselves, both the lower window and the upper window together, have a combined height of 4 ft. I am appealing this item because there are two windows in each room, both less than 6 feet from the ground, which offer ample opportunity for egress.

Regarding #9, Egress window in upper unit bedroom

Not an appeal, but an update: The egress windows in the upper-unit bedroom, also double-hung windows, are somewhat smaller than the windows in the lower unit bedrooms. During her inspection, the inspector noted the windows had a width opening of 20 inches and a height opening of 20 inches. The height of the opening was restricted by the pulley at the top of each window. Each of the pulleys has been removed, providing an extra 7 inches of height, so that the height is now 27 inches. The sash is sufficient "tight" so that the windows stay up when opened. The inspector can verify this during her reinspection on Thursday, August 12.
