

Dear Property Representative:

Your building was re-inspected for the Fire Certificate of Occupancy on September 29, 2010. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately. A reinspection will be made on October 13, 2010 at 11:00 am.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. Throughout SPLC 34.09 (3), 34.32 (3) Repair and maintain the window frame. Repair or replace all chipped, missing and deteriorated glazing putty throughout as necessary.
- 2. Unit 4 Living Room, Unit 6 Dining Room SPLC 34.09 (3), 34.32 (3) Repair and maintain the window sash. All openable windows must be able to remain in the open position when opened.
- 3. Unit 6 MSFC 1005.2 Provide an approved additional means of egress due to an inadequate number of exits. This unit requires two (2) exits, and was noted to only have one means of egress at time of inspection. Per result of appeal, this must be completed and approved under permit by October 12, 2010.

4. SPLC 34.09 (1) b,c, 34.32 (1) b,c - Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint.

You have the right to appeal these orders to the Legislative Hearing Officer.
