Hello,

I am reaching out to give my feedback regarding the Ward 5 maps. Although I have very recently moved to Ward 4, I was a resident of Ward 5 for several years. (I still feel that I am too new to Ward 4 to really have much to say about the change in boundaries.)

Ward 5 is incredibly diverse. There are some tough and amazing people who live there. Often, they don't feel well represented. I worry that some of these changes could exacerbate rather than help Ward 5 residents' concerns about representation.

To provide context, I lived at an address on Virginia St east of Dale, west of Rice, south of Maryland, and north of Front.

Options 1-2

I would've been moved into Ward 1. As a resident, I feel like I have concerns in common with neighbors <u>north</u> of Como Ave. <u>I care more about what happens in and around Marydale Park and Como Park</u> than what happens on University Ave and on Selby Ave. I would have been disappointed and frustrated by this change.

Option 3

I would've stayed in Ward 5, but my neighbors west of Dale/east of Lexington would have been grouped with Ward 1. I cannot speak on behalf of these residents, but I feel that the railroad (Front, Calvary Cemetery, Como Ave) supports a natural boundary.

Options 4 & 5

These boundaries make the most sense to me and match what I would identify as an area with common interest and need for representation. There are a few blocks carved out north and south of Front Ave west of Rice that I think are confusing. Why not follow the natural boundary that exists there?

The only other feedback I wish to convey is that it is not helpful to review these maps without other data/context. While it can be a good idea to recognize "natural boundaries" that confine a neighborhood, I realize there are histories of red-lining that may put some residents at more of a disadvantage. If a new boundary is suggested on a map with the intention that it will benefit them/give them a better chance of representation, then please provide us with that information.

To whom it may concern,

I have reviewed the <u>redistricting options</u> presented by the city. To be honest, none of them are very good, but neither is the current set of ward boundaries. I reside at 5 Crocus Place, in Crocus Hill (Crocus Place is a semi-circular road above the terrace down to I-35E.) *My* preference would be Option 1, which places us in Ward 1.

- The current arrangement having us in Ward 2 does us a disservice. Crocus Hill is an afterthought to the WestSide and downtown (which doesn't have that many residents yet, but is certainly growing.) Things that are important to us (e.g. Grand Avenue's health and the awful condition of Summit) don't matter at all to West Side or Downtown. This would be my complaint against options 2, 3 and 5. We get little attention from our councilwoman, which makes sense since we are a small part of her ward.
- My concern with Option 4 is that we are grouped in with Highland, which again is a very different set of concerns from us.
- Option 1, as I allude to above, at least puts us with people who share our concerns about Summit and Grand, though obviously they have other concerns on the other side of I-94. Of course it's not good that the Crocus Hill neighborhood is split up in this option, and if that could be fixed that would be wonderful. However, I don't know the population splits well enough to know if that's possible.

I understand that somebody's ox is always going to get gored in redistricting. That is a fact of life and you have to make the wards approximately equal in size. However, redistricting should group people with similar concerns together. My belief is that my neighbors and I share more with Ward 1 than Ward 2.

I believe public comment is still open--I was unable to attend the meetings this week, but wanted to register my (strong) preferences: I would endorse either Option One (which appears to be the primary proposal on the <u>main page here</u>) or Option Three

I have served in various capacities for community work in the Hamline Midway neighborhood -serving on the District Council in committees (Development; currently on Transportation) and two terms on our Board of Directors; I was involved with neighborhood representatives and Wards 4 & 1 on the community benefits fund initiative following the construction of Allianz field; and in the partnerships between Hamline University and Hamline Elementary.

In all of these efforts, I have been struck by the vitality of the current Hamline Midway district, and the three options which take a chunk of the Midway out of Ward 4 seem to set us on a path to break up the Midway district -- and potentially undermine significant existing community cohesion. Even if the district area remains the same, we would complicate efforts to coordinate with the city in the neighborhood, by requiring engagement across Wards. I am strongly opposed to options 2, 4, and 5.

But in these efforts I've also been struck by how central the business district south of University is to the health and needs of the Midway neighborhood north of University. The existing Ward division along University creates a strange pocket for Ward 1 into business areas that much more centrally/directly impact the communities currently in Ward 4. Put plainly, shifting the Ward 4 boundary south to 94 will strengthen efforts to create cohesive community/business collaborations. I strongly, strongly support options 1 or 3.

Dear Charter Commission,

I am a long time Ward 4 resident and parent of two children attending Galtier Elementary. I only recently understood that three of the five redistricting proposals include isolating the Southeast quadrant of the Midway neighborhood south of Minnehaha and east of Snelling. Galtier Elementary is in the very center of the area that would be eliminated from Ward 4.

My family lives west of Snelling and would be part of Ward 4 no matter what, but I am still concerned about this change. That is especially true because it is being proposed on the heels of the closure of Galtier, which has been especially heartbreaking for the families that live right around the school building who have been deeply invested in building the beautiful community there. Options 2, 4, and 5 would isolate that area from its previous Ward.

We are working hard to bring as many families as we can to join with Hamline Elementary to try to keep a strong community school in our neighborhood. We know there is a risk that Hamline, too, would be closed, potentially exposing our children to a second school closure before those displaced from Galtier finish elementary school.

Damaging the unity of the Midway with a new ward boundary that divides it into pieces would make it even more challenging to stabilize Hamline Elementary.

The closure of Galtier has fractured a strong community. We need a chance to rebuild relational ties that make our neighborhood its best, and doing that around a community school that unites the Midway is a powerful opportunity that would benefit from City Council leadership and organizing. The splitting up of our neighborhood at that time would hurt our chances of success.

I hope you all will prioritize Options 1 and 3 that protect the integrity of the Midway. Thank you.

My name is Bethany Gladhill, and I live at 627 Ashland in Saint Paul (Ward 1). I am writing today with concern about the proposed redistricting plan(s) for Saint Paul's seven wards.

I have read the 80-page study, and compared the 5 different proposed maps that I could find, and I am afraid they have provided me little information as to the redistricting criteria and process. My understanding is that redistricting is generally done, when done correctly, to balance out demographics in an area; however, I find vey little information about those demographics in the report. They information *seems* be be based on census data, which as we all know, was extremely flawed for the 2020 census, including what appears to be a persistent undercount of people of color. I am wary about making changes based on this data, which could have serious errors.

Nor do I see how, even if correct, this data flows to the redistricting plans. I know you have top mapping people on the city staff, but in my ward (Ward 1) in particular, the proposed maps seem wildly different, and I don't understand how they could achieve the same results.

I commend the Council's wish to keep long-held communities together, and respectfully request that ward redistricting be done as minimally as possible, and with a longer period of pubic commentary.

I commented about the Ward 5/Ward 1 boundary at your March 10 meeting, because I was concerned about splitting the neighborhood around Marydale Park. Now that I've looked at the newer options, I wanted to provide more input.

I do not like Option 1 or 2 because they include this split of the neighborhood around Marydale. I would prefer Dale or Western be the boundary to keep this section where the community has common interests and concerns together in one ward.

Option 3 does not include this split, which is good for the Marydale Park part of the North End, but it is an odd shape for Ward 5, and even odder for Ward 1. It would be harder for people to know which ward they are in.

Options 4, 5, and 6 do a much better job of keeping the North End lines closer to their current locations, but looking at the city over all Option 6 seems to be less disruptive for everyone. Option 6 makes smaller adjustments to all wards rather than shifting large areas of any one ward. It is closer to existing boundaries. Option 6 would be my choice.

Please weight the importance of **communities of interest**, namely **District council boundaries** and neighborhood boundaries over that of redrawn state legislative boundaries. For local issues, the local boundaries are much more meaningful.

Please, too, weight the importance of **simple shapes**, **straight lines and physical boundaries** highly and avoid the jagged boundaries. All 6 options have boundaries that zig zag up and down, most markedly between Ward 5 and Ward 1. The current W5/W1 boundary follows Front Avenue from Lexington to just past Rice, where it jogs around the capitol. While following Pierce Butler would be even better as it align with DC boundaries and the parallel RR tracks create a significant physical boundary, Front Avenue is nonetheless a logical and easy to follow alternative border, being a straight line and a major street.

Of the 6 options, Option 6 is the closest to aligning with communities of interest, but it still creates new divisions: W 7th, Mac G become more divided. Union Park continues to be divided.
