Dear Mr. Tea & Ms. Tea:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant 180 days for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday, January 25, 2022 at 10:00 a.m. via telephone** at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If you received the Certificate of Code Compliance by **January 25, 2022**, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received the Certificate of Code Compliance by **January 25, 2022**, please **contact Building Inspector Nathan Bruhn at 651-266-9033 to set up an inspection as soon as possible** to determine percentage of completion prior to the hearing or for more information, contact Joe Yannerelly at 651-266-1920.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on **Wednesday, February 9, 2022 at 3:30 p.m. in Room 300 Council Chambers.**
