Dear Mr. Tea & Ms. Tea:

This is to confirm that on February 8, 2022 at the Legislative Hearing at which you did not appear and we were unable to reach you, Ms. Moermond recommended laying the matter over to **Legislative Hearing on Tuesday, February 8 22, 2022 in Room 330 City Hall at 10:00 a.m.**

By close of business February 18, 2022 the following items must be completed:

- 1. Submit updated work plan for completing the project, including bids**
 - a. your February 8 submissions were not accepted. You only submitted a plumbing bid and that is not accepted, work was done without permit and should be resolved with the plumbing inspector.
 - b. You need to provide updated bids for all other trades, noting a Minnesota Licensed Electrical contractor has not pulled a permit for electrical work, nor do you have a HVAC/mechanical permit.
 - c. Your financing should include the amounts for all outstanding bids including permits that need to be pulled
- 2. Post an additional \$5,000 performance deposit with the department of Safety & Inspections,**
- 3. Submit updated proof of financing.** (You submitted a personal checking statement on February 8, this is not accepted. It should be moved to a segregated account dedicated only to this project);
- 4. Submit a new affidavit dedicating the segregated funds; and**



5. The property must continue to be maintained

This matter will go before City Council on Wednesday, **February 23, 2022** at 3:30 pm. in room 300 City Hall. If you are contesting Ms. Moermond's recommendation, you may appear in person or send written testimony to be added to the record to legislativehearings@ci.stpaul.mn.us or by voicemail at 651-266-6805. **Should you wish to address Council directly but not appear in person, please call me at the number below.** If you don't wish to contest, no further action is needed.
