Dear Mr. Tea & Ms. Tea:

This is to confirm that at the City Council Public Hearing the City Council continued the Public Hearing to March 16, 2022 at 3:30 p.m.

**By close of business March 11, 2022 the following items must be completed:**

- 1. Submit updated work plan for completing the project, including bids**
  - a. You need to provide updated bids for all other trades, noting a Minnesota Licensed Electrical contractor has not pulled a permit for electrical work (current permit is expired).
- 2. Post an additional \$5,000 performance deposit with the department of Safety & Inspections,**
- 3. Submit updated proof of financing and that funds are escrowed in segregated account;**
  - a. Your financing should include the amounts for all outstanding bids including permits that need to be pulled
- 4. Submit a new affidavit dedicating the segregated funds to the project; and**
- 5. The property must continue to be maintained**
