## **Functions, Programs and Services**

The ED Team implements and oversees the following functions, programs and services:

- Commercial real estate development, including large redevelopment efforts
- Manage Neighborhood STAR Program and N-STAR-funded projects
- Manage Cultural STAR Program and C-STAR-funded projects
- Manage 13 HRA-owned parking facilities and Parking Enterprise Fund
- Oversee tax increment financing policies, process and tracking
- Oversee conduit revenue bond financing policies and bond-funded ED projects
- Manage loan portfolio of over 120 loans valued in excess of \$17 million
- State/local grant funding coordination/project management





## Functions, Programs and Services (cont'd)

- Business retention, expansion, and attraction activities
- Respond to broad business resource requests and questions
- Entrepreneurship and small business development and lending
  - $\circ$   $\;$  Targeted funding initiatives, including Full Stack  $\;$
  - Special funding initiatives, including Commercial Vitality Zone (CVZ) program, civil unrest funding, and the recent COVID relief efforts

## **Project Highlights and Outcomes\***

- Active Projects: Currently working on 193 total projects/activities
  - **44 projects under construction\*\*** (Construction started but not complete)
  - **55 development-stage projects\*\*** (City/HRA financing has been approved)
  - **62 conceptual-stage projects\*\*\*** (City/HRA financing not yet approved)
  - **32 ongoing programs/activities** (not specific projects)

The 44 projects currently under construction have a total development cost of nearly \$93M

Completed Projects: Since 2020, the Economic Development Team has completed 77 construction projects\*\* with a total development cost of over \$30M (C of O issued and financing disbursed)



Also <u>excludes</u> nonconstruction projects (for most), TIF financings, and conduit revenue bond projects






### Recently Completed Projects 2020 - Present

## 2021 Neighborhood STAR Program & 2021/2022 Year-Round STAR Highlights

#### **2021 Neighborhood STAR Program Highlights**

- Requests: 74 applicants requested \$6,044,126 in grant and loan funds
- Approved: 24 proposals awarded \$1,685,975 in STAR loan and grant dollars
- Match: More than \$17 million in private/non-City dollars
- 12 out of 24 under contract

#### **2021/2022 Year-Round STAR Program Highlights**

- 22 proposals approved: \$652,396
- Match pledged: \$526,416
- 10 out of 22 under contract

## 2020/2021 Cultural STAR Highlights and Outcomes

#### **2021 Highlights**

- \$1,414,050 awarded to 90 projects
- Received 118 eligible applications requesting \$2,486,050 in funds

#### **2021 Highlights**

- \$1,522,800 of Cultural STAR plus \$1.17 million in CARES funds awarded
- 86 organizations received General Operating grants for COVID relief
- 80 Saint Paul artists supported by Springboard for the Arts' Emergency Relief Fund

## **2022 Cultural STAR Application Periods**

#### **Program Goals**

Promote cultural vitality and economic growth, particularly in the downtown Cultural District, by strengthening the arts and culture community

#### **2022 Highlights**

- Round 1
  - Application period: March 22 April 29, 2022
  - Proposed projects must take place between August 1, 2022 and July 31, 2023
- Round 2
  - Application period: July 15 August 26, 2022
  - Proposed projects must take place between January 1, 2023 and December 31, 2023

- Special arts-related projects
  - Mural on Sibley Street railroad bridge near Lambert's Landing (pending CP permission)
  - NEA Our Town proposal outreach for 2022 application cycle

## **Business Assistance Fund Update**

- Guidelines were approved by the HRA Board on February 9 (easier intake, wider marketing)
- Guidelines and an intake form were posted to PED's webpage on March 17
  - o Business Assistance Fund Guidelines and Intake Form
- To date, there have been 103 visits to the guidelines online
- Two financing proposals are currently under review by ED team staff and one is in the pipeline

## LISC Community Asset Transition (CAT) Fund Participation

**\$500,000** allocated to support the LISC Community Asset Transition (CAT) fund, a leveraged capital pool with additional support

- Staff is working with CAO to execute a Master Participation Agreement with LISC
- Staff is building a project pipeline through internal discussions and community outreach
- When a project is identified, the request will come before the HRA Board for approval (if requested amount is \$50,000 or more)

## St. Paul & Minnesota Foundation Main Street Revitalization Program Participation

- Applications for the St. Paul and Minnesota Foundation's \$7.28 million East Metro Mainstreet program are scheduled to open in early Summer this year
- Projects need \$2 of matching funds for every \$1 of Mainstreet grant funds
- SPMF is actively raising matching funding from nonprofit, philanthropic, local government and private sector partners
- We hope to leverage this program to the greatest extent possible with our **\$500,000** of Civil Uprising Funds. Our funds, per the December resolution and just like the Mainstreet program, must be used for capital investments such as renovation or construction of real property


