Synopsis :

On 12-27-21, SPPD Officers were dispatched to the address of 1654 Edmund Avenue on the report of a burglary. There appeared to be forced entry to the rear of the address. SPPD Officers cleared the home and discovered no suspects inside. There were no arrests at the time of the report.

It should be noted that while clearing the home, the home was filled with trash and was in an unlivable condition.

Narrative :

On 12-27-21, We, Squad 184 (Phan/A. Lyfoung) along with other Squads, were dispatched to 1654 Edmund Avenue on the report of a burglary that occurred at 0530 hours. Call comments stated that their neighbors home may have been burglarized this morning. Comp advised that they were advised by another neighbor about the incident. Neighbors noticed that someone was unloading items from the back of the house. Comp advised dispatch that the owner of the home was not returning due to medical issues. Comp wanted Officers to check the address.

Upon arrival, we met with the comp at 1656 Edmund Avenue. Comp, Judy Swett (C/P: 612-702-7496), advised us that a neighbor told her they saw people moving property out of 1654 Edmund at 0530 hours. Swett advised that the suspects had a waiting running vehicle in the back and were loading property into the vehicle. The vehicle then left.

Swett advised that she had spoken to the niece of the owner who advised her that the owner would not be returning due to health issues. Swett did not have any information for the owner's niece.

We checked the front door and observed that it was ajar but chained from the inside. We checked the rear of the address and observed a damaged rear entry door which appeared to be forced open. We advised dispatch and requested additional squads to clear the home.

Prior to making entry, we made announcements advising any in the home to come out with their hands up. After numerous announcements, we made entry to clear the home. While inside the home, we struggled to move throughout the piled up trash in the home. The whole house had trash built up at least waist high and there was trash blocking the front entry and interior doors from opening. After making our way through the unlivable conditions, we did not discover any suspects in the home.

We checked the scene for any latent prints and could not discover any. Photos of the incident were taken and uploaded to the media vault. The comp did not have any suspect information.

It is unknown at this time if anything is missing from the home and we were not able to find owner and contact information to the owner.

A board up crew was requested to secure the doors to the home.

There is no further information at this time.

On 12/29/2021 I, Squad 758 (Sgt. B. Ficcadenti), called and spoke with SWETT. SWETT stated that she was out of town when neighbor sent her a text on the 27th about someone taking items from 1654 Edmund Ave. SWETT asked the neighbor if they called police and they stated that they did not. SWETT stated that she called police and later came home in case police needed to speak with her. SWETT stated that the home belongs to "LINDA" but LINDA has not lived there for about three to four years and has been vacant during that time period. SWETT stated that LINDA would usually come about once a week to get mail but she hasn't seen her in about a year or so. I asked SWETT if she had any contact information for LINDA and she stated that she did not.

I later used the STAMP (property information) website to search for 1654 Edmund Ave and located an owner of Linda A SULLIVAN. I later performed a CLEAR search for SULLIVAN and located a phone number of 651-644-4686. I got a prompt stating that the number was temporarily disconnected.

Narrative :

I, Sgt Weyker was assigned to further review this case for investigation. I had been assigned a burglary that occurred at 1698 Thomas. This house was owned by Linda Sullivan, the owner of 1654 Edmund. Sullivan was recovered from inside the 1698 Thomas address on 10-31-21, unconscious and close to death. Sullivan's mother died in 2018 and Sullivan has taken over the home since her mothers passing. Sullivan spent over a month at Regions hospital due to her medical conditions. While she was in the hospital, recovering, she found out her home on Edmund was burglarized as well.

At this time, due to Sullivan not being able to go to her home and see what was taken, damaged or destroyed, we don't know what is missing. I reviewed the BWC and observed the house to be in bad shape, very messy, and it appeared to be ransacked.

I have spoke with Sullivan many times. She has been transferred to a rehabilitation home to assist in getting her well enough to be on her own. Sullivan said se wants to go home. I explained the home is not in a livable state and is not good for a person in poor health.

I located two of Linda A Sullivan's credit cards in Janel Torres possession when she was arrested. See CN# 21-243-401.

The burg at 1698 Thomas is 21-248-097.

I asked RCAO to contact Janel Torres attorney for her other crimes and ask if she would be able to provide further info as to the location of some of Sullivan's items. To date, I have not received an update.

Sullivan had fraud done on her financial accounts.

At this time, until I am unable to identify a suspect who committed this burglary, I will pend this case.
