This is to confirm that at the Legislative Hearing on April 26, 2022, Legislative Hearing Officer Marcia Moermond recommended that the City Council grant to **May 16, 2022 for compliance with the Fire orders (dated April 1, 2022) and Summary Abatement and Correction notices (dated April 25 & 26, 2022).**

These were sent you via email on April 26 and mailed by your inspector, but I have also attached them here for your records.

The City Council Public Hearing is scheduled for Wednesday, May 11, 2022 at 3:30 pm. in room 300 City Hall. After the May 11 Public Hearing, Ms. Moermond will review this case under a new resolution at a May 17 Legislative Hearing at 11:00 a.m. to determine if you have abated the nuisance(s) listed above on deadline. The City Council Public Hearing for that will be scheduled for Wednesday, May 25, 2022 at 3:30 pm. in room 300 City Hall. You are welcome to attend any of these hearings. If you are contesting Ms. Moermond's recommendation from the May 17 hearing, you may appear in person or send written testimony to be added to the record to [legislativehearings@ci.stpaul.mn.us](mailto:legislativehearings@ci.stpaul.mn.us) or by voicemail at 651-266-6805. **Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing via the link above.**
