Staff Comments

Hauler records show that the reason for the invoices not being sent to the incorrect address was due to the CSR accidentally copying the service address over the billing address on the account. The property owner called the hauler on 1/27/2022 to notify then that they had never received their Quarter 4 2021 invoice. Following this complaint, the hauler updated the mailing address and sent a copy of the current Q1 2022 invoice. However, since the property owner would have not received any invoices or notices of nonpayment during the Quarter 4 2021 the hauler recommended that we remove that assessed late fees of \$14.85. Therefore, staff recommends removing the assessment.

Hello.

This is Eman and my account number is 021434 for Highland Sanitation.

The October invoice kept being sent to my old house (858 Stickney, not my current billing address). By the time the issue was resolved, it was January 27 and I paid off the invoice to St. Paul via PayPal and then the 2nd invoice for January was sent, but also to the old house and then it was emailed to me on January 28 after it was originally sent on January 5th. I thought it was still the same issue, so I kept contacting their office and kept being told that a manager was looking into it and then going to call me back. I never got a call back and then I called a couple days and got clarification regarding the 2 separate invoices. I paid the \$100.71 for the January invoice to Highland on the website via Paypal, but I found a \$14.85 fee on my St. Paul assessments and now late fees on the April invoice. Please inform me on how to get rid of the St. Paul assessment fee. This has been a very long and frustrating process, as we have been customers since 2017 and only last year did the invoices start being sent to 858 Stickney and not our primary house, 1320 9th Ave. Let me know how to proceed.

Hello Eman,

My name is Clare Pillsbury and I work for the City of Saint Paul garbage program. The Office of Financial Services here at the City of Saint Paul forwarded us an email that you had sent regarding the Quarter 4 2021 garbage assessment for your property at 585 Stickney St. I was able to get more information on your account from Highland Sanitation and they confirmed that the reason for the invoices not being sent to the incorrect address was due to the CSR accidentally copying the service address over the billing address on the account. They were notified by you about this error on January 27, and put in a correction on the same day. Since you

would not have received any invoices or notices of nonpayment during the Quarter 4 2021 Highland Sanitation they recommended that we remove that assessed late fees of \$14.85. Therefore, we will be removing the assessment at a rescheduled legislative hearing date on May 3 from 3:00 - 4:00 PM. Although it is not required for you to attend the legislative hearing, please let me know by the end of the day tomorrow if you would like to attend.
