# Reparations Legislative Advisory Committee Companion Report to Ordinance Establishing the Saint Paul Recovery Act Community Reparations Commission

## INTRODUCTION

The Reparations Legislative Advisory Committee was a limited-term committee which met for 1 year: July 2021 through June 2022. The Advisory Committee's membership represented multiple perspectives, including education, faith, community activism, business, labor and health, youth and local historians. It met twice a month and conducted public meetings to receive feedback on its work. With the proposed ordinance and this companion report, the Advisory Committee lays the groundwork for the permanent establishment of the ***Saint Paul Recovery Act Community Reparations Commission***. Once established it will advise and recommend actions to support the creation of generational wealth for the American Descendants of Chattel Slavery and boost economic mobility and opportunity in the Black community.

The Reparations Legislative Advisory Committee envisions that the work of the Saint Paul Recovery Act Community Reparations Commission will be to ensure delivery of reparations to the members of the American Descendants of Chattel Slavery (ADOCS) community to establish the well-being of the ADOCS community. ***This Commission should be informed by the United Nations principles for reparations*** including acknowledgement with action through Restitution, Rehabilitation, Compensation, Guarantee of Non-Repetition and Satisfaction in the pursuit of economic justice.

***The Reparations Legislative Advisory Committee points to the importance of funding for these reparations' endeavors.*** First, adequate funding and staff must be provided to fulfill its mission. Second, there must be funding identified to implement recommended programming and possible direct payments. The establishment of a commission means little if there is no budget to support implementation of policy and programmatic recommendations.

***The Legislative Advisory Committee recommends that future programs be implemented in a way which measures their impact.*** Measuring change from an agreed upon baseline of conditions is critical for both identifying how programs should be improved and what programs need to be developed. The back and forth of measuring, evaluating and adjusting programs should be an open and transparent communication process between the Saint Paul Recovery Act Community Reparations Commission and involved city departments. The result of these discussions will inform the policy and programmatic recommendations the Commission makes to the Mayor and City Council.

The Legislative Advisory Committee's work was immensely informed by the cooperative undertaking of the Saint Paul Public Library and Saint Paul City Council in developing a broad and deep list of reparations resource material. Items include news stories, academic journals, law journals, videos, podcasts and a review of the library's "Saint Paul Collection." Moving forward, we strongly recommend this list be maintained and updated to inform the work of the Commission, the community at large.

## ORDINANCE LANGUAGE COMMENTARY

### Purpose of Commission

***The Saint Paul Recovery Act Community Reparations Commission (hereinafter referred to as the "commission") serves as an advisory body to the mayor and city council on repairing the damage caused by public and private systemic racism in the City of Saint Paul which resulted in racial disparities in generational wealth, homeownership, health care, education, employment and pay, and fairness within the criminal justice system among the American descendants of chattel slavery.***

The Saint Paul Reparations Legislative Advisory Committee recommends establishment of a permanent commission to deliver reparations to the members of the American Descendants of Chattel Slavery (ADOCS) community to establish the well-being of the ADOCS community. The commission will deliver acknowledgement with action through Restitution, Rehabilitation, Compensation, Guarantee of Non-Repetition and Satisfaction in the pursuit of economic justice. The commission will need to think of this in terms of the social, political and economic systems which created disparities in generational wealth.

The term American Descendants of Chattel Slavery (ADOCS) was considered carefully and reviewed by the committee. This is the term used originally in the resolutions passed by the City Council in January 13, 2021 beginning the City process of actively addressing the implications and responsibility for reparations. It was also used in the resolution establishing this advisory committee June 16, 2021. Another way to describe the identity of ADOCS for the Commission's purposes included American Descendants of Slavery (ADOS), which is a term used commonly throughout the country and even internationally.

The Saint Paul Recovery Act Community Reparations Commission will, via committed resources from the City of Saint Paul, shepherd monetary, geographic and political resources to the cause of reparations and generational wealth creation for the ADOCS Saint Paul community.

### Establishment; Terms; Vacancies and Qualifications

- a) Saint Paul Recovery Act Community Reparations commission established. There is hereby established a Saint Paul Recovery Act Community Reparations commission consisting of eleven (11) at-large members appointed by the Mayor of Saint Paul with the advice and consent of the city council.***
- b) Terms. Of the members first appointed, three (3) shall be appointed for a term of one (1) year, four (4) for a term of two (2) years, and four (4) for a term of three (3) years. Thereafter, the term of each member shall be three (3) years. Members shall serve no more than 2 consecutive terms.***
- c) Vacancies. Vacancies on the commission for whatever cause shall be filled by the mayor through the open appointment process for the unexpired term.***
- d) Qualifications. All members shall be residents of the City of Saint Paul.***
  - i. To the extent possible, members shall be representative of the city's diversity of neighborhoods, races, cultures, ages, abilities, incomes and sexual orientations consistent with city's diversity and equity goals.***
  - ii. Preference shall be given to candidates who demonstrate lived experience as it pertains to the work of the commission, are engaged in the local community and understand the role of reparations in addressing the impacts of chattel slavery.***

The Advisory Committee intentionally described the qualifications to serve on the Commission in broad language to ensure a wide-ranging group of residents may apply to be of service. Given the history and

legacy of chattel slavery the City should seek a diverse body of individuals who bring a multiplicity of experiences, especially those relating to the ongoing impact of redlining, job discrimination, housing discrimination, encounters with the legal systems, as well as other historic discriminatory practices.

The Legislative Advisory Committee strongly recommends that the mayor and council privilege in terms (proportion of) representation those with the lived experience of racially discriminatory policies. The focus should be on those with direct lineage to chattel slavery and those from the City of Saint Paul who have been impacted by policies and practices and/or procedures which have caused intergenerational harm.

In addition to the Commission membership criteria listed in the proposed ordinance, the Advisory Committee would like to draw attention to several member characteristics which would benefit the work of the Commission.

- To the greatest extent possible, there should be community involvement in the Commission member appointment process.
- Commission members should demonstrate interest and involvement in the community and issues that affect the lives of people to be impacted by the work of the Commission.
- The Commission should be comprised of a broad variety of community and professional perspectives – such as educators, faith leaders, community activists and leaders from the business community, labor and health care.
- The Commission should also prioritize those with specialized expertise in the areas relevant to the work of the Commission; such as historians, economists, legal analysts and policy experts.
- Geographic representation of Commission members from throughout the city would strengthen overall community understanding and involvement of the work of the Commission.
- Both adult and youth should also be encouraged to apply to serve on the Commission.

The Legislative Advisory Committee recommends that the Commission be 75% ADOCS. However, it does so with the understanding that use of a specific proportion may not be consistent with government legal requirements. It is for this reason that there is such a strong emphasis on inclusion of those with actual lived experience as described above.

The Mayor and Council should actively consider consecutive terms to allow those with short terms to serve a full term in the beginning, thus providing that someone appointed to a 1-year term may be immediately appointed to serve a 3-year term thereafter.

## Staff and Budget

- a) Staff. The commission shall be staffed by Human Rights and Equal Economic Opportunity (HREEO). The responsibilities of this department staff include:**
- i. Serving as staff and recording secretary to the commission;**
  - ii. Reporting on departmental and/or citywide efforts on topics intersecting with or directly relating to the commission's work;**
  - iii. Advising the commission on matters pertaining to reparations when requested;**
  - iv. Administering the commission's budget; and**
  - v. Providing additional support service as needed.**

- b) Budget. For the operations of the commission, including staff salaries and other related expenses, such as travel, training, per diem, postage, copying and supplies, an annual proposed budget shall be submitted to the appropriate officials for inclusion in the city's budget.**

The Legislative Advisory Committee notes that work on budgeting for the staffing of the Commission should be initiated soon, ideally as a part of the City's 2023 budget process, and happen in conjunction with Mayor and Council consideration of the proposed ordinance language.

The Legislative Advisory Committee emphasizes the importance of timely consideration for funding of programming and possible direct payments resulting from the deliberations and recommendations of the Commission. Such funding should include "set asides" for staffing and programming from ARP or other funds. The Advisory Committee notes the importance of immediately examining the use of the uniquely available ARP dollars, given the time sensitive nature of this money.

## Meetings

- a) The commission shall establish a regular time and place of meeting and shall meet monthly. At its first meeting each year, the commission shall elect its chair and vice chair.**
- b) The commission shall establish rules and procedures for the conduct of its business. Notice of all meetings shall be published in accordance with proper notice procedures. A majority of all qualified commissioners shall constitute a quorum, and all business may be transacted by a majority vote of such quorum. Unless otherwise provided, any action taken by the commission shall be by the affirmative vote of a majority of its members.**
- c) The commission shall keep a public record of its meetings. Copies of all minutes, motions, resolutions, findings and reports shall be available to the public upon request.**

The Commission should, in the establishment of its rules and procedures

- Explicitly state meetings are to be open to the public.
- Strongly consider providing a standing agenda item each month providing an opportunity for public input.
- Establish a public notification period in advance of meetings, such as 7 or 10 days.

## Powers and Duties

**The commission shall act in an advisory capacity to the mayor and city council in all policy and budget matters pertaining to reparations within the city through the following activities:**

- a) Shall be empowered to make short, medium and long-term policy, program and budget recommendations to specifically address the creation and sustainment of generational wealth for the American Descendants of Chattel Slavery and to boost economic mobility and opportunity in the American Descendants of Chattel Slavery community;**
- b) Shall establish a work plan annually which will serve to notify city officials of the commission's priorities and activities;**
- c) Shall develop time-based evaluations of city expenditures using quality of life metrics as indicators of progress on reparations;**
- d) Review and advise on city programming and budgeting related to reparations;**
- e) Serve as an advocate for reparation efforts within the City; and**
- f) Conduct all business in such a manner as to encourage and utilize maximum citizen participation.**

The development of policies, plans, programs and their evaluation requires partnership between relevant city departments and the Commission. The Mayor and City Council should set the tone for this ongoing relationship.

The need for ongoing communication among the Mayor's Office, City Council and Administrative Departments was discussed thoroughly by the Legislative Advisory Committee. The Committee envisioned several aspects of this ongoing communication –

- The Commission should receive and review periodic reports from these city entities, as to key quality of life metrics. These metrics would inform the key areas for the Commission's focus and provide a baseline for measurement of improvement resulting from Commission recommendations and resulting city action.
- In addition to using the afore-mentioned metrics to inform Commission recommendations and actions, the Commission should actively seek input from the community to inform the prioritization of the Commission's work.
- As programs are established and implemented, the Commission should continue to act in partnership with city departments to ensure the metrics clearly identify both areas of success and areas where additional programming or program changes are necessary.

The Legislative Advisory Committee points to the vital importance of funding for reparations work in the City of Saint Paul through programming and direct cash payments for ADOCS. Sources for potential funding to be considered could include American Rescue Plan (ARP), sales taxes, land sale proceeds and philanthropic contributions.

These monies may be distributed by the city department staffing the work of the Commission, or perhaps more appropriately by the city department executing the program. An example of this may be the provision of city funds for reparations through housing and land policy and programs being implemented by the city's Department of Planning and Economic Development.

The ordinance specifies the Commission shall produce a report at least annually. The Legislative Advisory Committee notes that additional statements or reports may be needed from time to time to provide advice and input on current policy, legislation, planning and budget matters under consideration by the city.

The LAC strongly supports the use of Commission resources to assist in genealogical work necessary for effective reparations efforts.

## Compensation

***Each member of the Saint Paul Recovery Act Community Reparations Commission shall be paid seventy-five dollars (\$75.00) for each meeting of the commission the members shall attend. In addition, the commission may, from time to time, delegate to another commission or committee member(s) having the responsibility of representing the commission at special meetings or public hearings. Those commission member(s) serving as delegates shall receive fifty dollars (\$50.00) for such meetings or hearings that the member shall attend. The compensation set forth herein shall be the entire compensation to commission members for the performance of their duties. The City shall from time to time evaluate the compensation provided to commission members.***

The Legislative Advisory Committee unequivocally recommends compensation be provided for Commission members to offset expenses such as parking, childcare and time away from work incurred related to the work of the Commission.

## APPENDIX 1: COMMUNITY COMMENTARY

**Virtual sessions** co-hosted by East Side Freedom Library April 7 and April 29, 2022 with an estimated participation of approximately 125-150 individuals at the 2 events.

**In-person sessions** held at Dayton's Bluff Recreation Center April 14 and Rondo Library April 21, 2022 with an estimated participation of more than 50 individuals at the 2 events.

*Note: the comments received in these sessions covered a variety of topics. Some of the topics are specifically addressed as components of the draft ordinance, while others pertain to the work the commission will be undertaking when it is seated. Finally, commentary also covered the roles of the mayor, city council and others. The Advisory Committee noted the scope of its mission was drafting the ordinance and committed to organizing and sharing commentary for future use by all interested parties.*

### Composition of Commission

- People of all ages should be included in commission.
- A majority of Commission members must be ADOCS/foundational Black Americans.
- Commission should include members who are knowledgeable about reparations, whether or not they are Saint Paul residents.
- Commission should be reflective of the (wealth/education/other demographic) diversity of the ADOCS population.
- "Preference shall be given" seems like weak language (Advisory Committee noted its vibrant discussion of this issue and its efforts to avoid discriminatory language.)

### Importance of Genealogical Research

- Resources need to be made available to help residents research heritage and determine eligibility for reparations' programming
- In addition to assistance for genealogical research, it makes sense to help people find other records, land deeds and so on that clarify and illuminate relevant history.

### Key Recipients of Reparations Work in Saint Paul

- Keep focus on ADOCS, don't get broader in application
- Saint Paul should begin its efforts looking at Rondo
- Very helpful to target descendants of Rondo community.
- Reparations should be available to all Saint Paul residents descending from the trans-Atlantic slave trade.
- Need to cover those harmed by the maintenance of systemic racism in Saint Paul.
- The ordinance does not define ADOCS. Is this something that Commission will do?
- Implore city to focus on lineage and separation, so people can identify themselves.
- Need to be clear this should be foundational Black Americans, and not more recent immigrants who are not.

### Nature of Reparations

- Reparations should be tangible and directed toward foundational Black Americans.
- Need to begin talking about the source of funding for reparations efforts, including ARP and other sources
- Need to be clear that reparations are (in large measure) repayment for free labor.

- Reparations is about addressing the disparity in generational wealth.
- Important to note foundational Black Americans have been denied the effect and accumulation of generational wealth.
- Reparations programming could include revised regulations on real estate transactions, such as nondisclosure of prospective homebuyer, pending purchase agreement or pre-approval letter.
- Need funding ideas that move beyond direct tax redistribution.
- We need to avoid approaching reparations programming/efforts/payments avoiding a “scarcity” or deficit mind-set.
- The first thing the commission does should be direct cash payments to foundational Black Americans. (Could do this based on content of 1870 census)
- Programming is not adequate. We have seen programs which end up benefitting others (not us as the intended population). Need to be direct with cash payments or land.
- Reparations needs to be more than an apology and include school loans, cash payments, etc.
- Goal is to close the racial wealth gap and address the harm done by the city to its Black residents.
- Legacy down-payment assistance fund, forgivable after 5 years.

### **Education**

- Educational efforts need to begin with effectively laying the groundwork in the larger Saint Paul community to support the work of the commission. Leadership should come from a variety of places, including the mayor and other elected officials.
- Need to compile and share stories as a part of educating ourselves and the community.
- The commission needs to include in its core mission the importance of (ongoing) education on reparations. This should have a related benefit of developing support for those efforts.
- Do educational work in partnership with community organizations with knowledge and demonstrated commitment, via sponsorship, co-signing on and supporting reparations initiatives)

### **Ongoing Community Participation/Input**


- A part of the community conversation (to be facilitated by the Commission) needs to involve a truth telling for experiences to be shared and community healing to begin.
- How can community members participate in the ongoing process to establish the commission and later with its efforts?

### **General Comments**

- City should consider composition of commission in the context of other (educational, philanthropic, faith-based) institutions whose missions and work overlap.
- Needs to be partnership with local philanthropic organizations.
- Hope commission will address ADOCS, as well as structural trauma that has happened over time
- Commission needs to be formed as quickly as possible to begin this important work.
- The local action needs to spur a call to action for reparations at the state (and federal) levels.
- Important to look at models other communities (and states) have used in establishing reparations efforts to see what might also be a good fit for Saint Paul.
- What is the vision for the ongoing relationship between the Commission, Mayor, Council, City Departments, etc.?
- We have every reason to distrust government, but we are also using local government for the process. It requires us to be strategic. We need to find ways to push back and reimagine what it should look like for government to truly engage with our community.

Committing to racial healing through the exploration of reparations for American descendants of Chattel Slavery Living in Saint Paul.

WHEREAS, the institution of slavery in the United States, beginning in 1619 and continuing through 1863, enriched American industries, commercial and financial corporations and transformed the newly established United States into an international economic power through the oppressive, dehumanizing and torturous system of enslaved Black labor; and

WHEREAS, after slavery ended in the US, the slaveowners were compensated for the loss of their slaves, but those who had been held in bondage were never compensated for their labor, despite the promise of "40 acres and a mule"; and

WHEREAS, although slavery was illegal in Minnesota, Dred Scott and Harriet Scott were in bondage at Fort Snelling as well as other African Americans who were used for enslaved labor by US Army officers, which was in violation of the Northwest Ordinance of 1787 and the Missouri Compromise of 1820; and

WHEREAS, in the aftermath of slavery, African American citizens of this country continued to face brutal discrimination, as evidenced by Jim Crow, forced segregation, mass atrocities in Tulsa and Rosewood, the lynching period and to this day, mass incarceration; and

WHEREAS, in Saint Paul, systemic discrimination was perpetrated through redlining and racial covenants, access to housing, environmental injustice and the removal of Saint Paul's Rondo neighborhood - the center of Saint Paul's African American business, residential, spiritual and cultural life - for the construction of Interstate 94; and

WHEREAS, the pervasiveness of structural institutionalized racism in Saint Paul and all of American society has led to overwhelming black-white disparities in every area of endeavor, from housing to education and employment, business investment, economic prosperity, health and wellness, including life expectancy and infant mortality; and

WHEREAS, according to the November 2020 edition of the New England Journal of Medicine, reparations are now widely considered to be the most effective means of breaking down the societal structure related to power, money and access to resources, and indeed may be the only solution that can be applied intergenerationally that "would be an investment in the future and in reducing disparities that have been intractable for generations"; and

WHEREAS, local and state governments throughout the US have demonstrated a commitment to address these disparities by creating programs to generate public and private sources of funding, including dedicating tax revenues from enterprises that have historically profited from targeting African American consumers and other forms of discrimination that have fueled black-white disparities; and

WHEREAS, the tragic killing of George Floyd at the hands of Minneapolis police officers has led to local, national and international reckoning of the immorality of the racial hierarchy that exists under our so-called democratic institutions, and the founding values of this nation, “that all people are equal, that they are endowed by their Creator with certain inalienable Rights, that among these are Life, Liberty and the pursuit of Happiness;

NOW THEREFORE BE IT RESOLVED that the City Council of Saint Paul does affirm that there can be no further delay in engaging all of Saint Paul in a process of racial healing and righting these wrongs; and be it further

RESOLVED, that the City Council of Saint Paul, does herein apologize and commit to making amends for its participation in and sanctioning of institutional racism against the American descendants of chattel slavery; and be it further

RESOLVED, that the City Council of Saint Paul does herein apologize and commit to making amends for Dred Scott being held in bondage at Fort Snelling and its enforcement of institutional racism and its accompanying discriminatory practices; and be it further

RESOLVED, that the City Council of Saint Paul apologizes and commits to making amends for allowing the construction of Interstate 94 to destroy a vibrant Black community and successful Black businesses; and be it further

RESOLVED, that the City Council of Saint Paul calls on all organizations and institutions in Saint Paul that have advanced and benefited from racial inequity to join the city in these apologies and invites them to address racism within their own structures and programs and to work with the city to more comprehensively address systemic racism; and be it further

RESOLVED, that the City Council of Saint Paul calls on the State of Minnesota and our federal delegation to initiate policymaking and provide funding for reparations at the state and national level; and be it further

RESOLVED, that the Saint Paul City Council commits to use its authority to establish, within the next six months, a legislative advisory committee to work with the Administration to create the roles and responsibilities for a new city commission to be known as the Saint Paul Recovery Act Community Reparations Commission; and be it further

RESOLVED, the Saint Paul Recovery Act Community Reparations Commission shall be empowered to make short, medium and long term recommendations to specifically address the creation of generational wealth for the American Descendants of Chattel Slavery and to boost economic mobility and opportunity in the Black community; and be it further

RESOLVED, the Saint Paul Recovery Act Community Reparations Commission, as envisioned, will make significant progress toward repairing the damage caused by public and private systemic racism in the City of Saint Paul, and will issue a report for consideration by the city, which will focus on but not be limited to strategies to grow equity and generational wealth, closing the gaps in home ownership, health care, education, employment and pay, and fairness within criminal justice among the American descendants of chattel slavery.

At a meeting of the City Council on 1/13/2021, this Resolution was Passed.

Establishing the Saint Paul City Council Legislative Advisory Committee on Reparations.

WHEREAS, the Saint Paul City Council adopted Resolution 21-77 on January 13, 2021 committing to racial healing through the exploration of reparations for American descendants of Chattel Slavery Living in Saint Paul; and

WHEREAS, Resolution 21-77 specifically

- 1) apologized and committed to making amends for -
  - a. its participation in and sanctioning of institutional racism against the American descendants of chattel slavery
  - b. Dred Scott being held in bondage at Fort Snelling and its enforcement of institutional racism and its accompanying discriminatory practices
  - c. allowing the construction of Interstate 94 to destroy a vibrant Black community and successful Black businesses
- 2) called on other to take action, including -
  - a. all organizations and institutions in Saint Paul that have advanced and benefited from racial inequity to join the city in these apologies and invites them to address racism within their own structures and programs and to work with the city to more comprehensively address systemic racism
  - b. the State of Minnesota and our federal delegation to initiate policymaking and provide funding for reparations at the state and national level
- 3) committed to establish a Legislative Advisory Committee -

- 4) described the role of the Saint Paul Recovery Act Community Reparations Commission which
  - a. shall be empowered to make short, medium and long-term recommendations to specifically address the creation of generational wealth for the American Descendants of Chattel Slavery and to boost economic mobility and opportunity in the Black community
  - b. will make significant progress toward repairing the damage caused by public and private systemic racism in the City of Saint Paul, and
  - c. will issue a report for consideration by the city, which will focus on but not be limited to strategies to grow equity and generational wealth, closing the gaps in home ownership, health care, education, employment and pay, and fairness within criminal justice among the American descendants of chattel slavery

WHEREAS, under Section 3.01.8 of the City Charter, the Council has the authority to establish a legislative advisory committee for no longer than one year to bring forward policy and legislative recommendations for Council consideration on reparations; now, therefore, be it

RESOLVED, the Saint Paul City Council determines it is in the public interest to provide a nominal stipend to support to these community advisors who bring valuable perspectives and whose presence builds public trust, ensures transparency and accountability; and be it further

RESOLVED, the Saint Paul City Council establishes a \$50 stipend per meeting for the advisory committee conveners and members which is intended to help defray expenses associated with providing service to the committee for their time and effort spent participating; and be it further

RESOLVED, the Saint Paul City Council will provide professional and clerical staff support to the work of the Reparations Legislative Advisory Committee; and be it further

RESOLVED, the Saint Paul City Council charges the committee with developing the policy proposals and enabling legislative proposals for the establishment of the Saint Paul Recovery Act Community Reparations Commission - whose mission it will be to recommend actions to address the creation of generational wealth for the American Descendants of Chattel Slavery and boost economic mobility and opportunity in the Black community; and be in finally

RESOLVED, the Saint Paul City Council requests a written report from the Reparations Legislative Advisory Committee no later than Friday June 10, 2022, which shall be presented to the City Council Wednesday June 15, 2022 at 10AM and the Reparations Legislative Advisory Committee disbanded thereafter.
