Dear Walgreens #15272:

The Department of Safety and Inspections (the "Department") is recommending adverse action against the Cigarette/Tobacco license held by Walgreen Co., d/b/a Walgreens #15272, for the premises located at 1110 Larpenteur Avenue in Saint Paul (the "Licensed Premises") for a first-time flavored tobacco product violation.

Saint Paul Legislative Code section 324.07(j) prohibits a licensee from selling, offering for sale, or otherwise distributing any flavored products.

Saint Paul Legislative Code section 324.10(b)(2) sets the presumptive penalties for violations of provisions of the Legislative Code relating to the display, possession, or multiple incidents of sales of menthol or flavored tobacco products. Under section 324.10(b)(2), the presumptive penalty for a first-time violation is a 10-day license suspension.

The Department asserts that the following facts, along with photos of the violations attached herein, constitute proof of a violation of section 324.07(j) of the Saint Paul Legislative Code by a preponderance of the evidence.

Synopsis of Alleged Facts:

On May 12, 2022, Department Inspector Voyda went to the Licensed Premises for a complaint inspection. Inspector Voyda spoke with the store manager, Megan Jensen, and informed her that the Department received a complaint of the business selling flavored tobacco products. During the inspection, Inspector Voyda saw in plain sight and photographed four (4) flavored tobacco products behind the counter/cash register. After the inspection, Voyda told the manager that the flavored tobacco products that were found could not be sold at the location. He also advised the manager to remove all flavored products, email the corporate office to make them aware of the violations found, and contact him with any questions.

You have three (3) options to proceed:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **June 8, 2022,** I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on a City Council Consent Agenda for a 10-day suspension of your license.

2. If you wish to admit the facts but you contest the 10-day suspension penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **June 8, 2022.** The matter will then be scheduled before the City Council to determine whether to suspend the license. You will have an opportunity to appear before the Council and make a statement.

3. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (the "ALJ"). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **June 8, 2022.** At that hearing, both you and the City will appear and present witnesses and evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify, or reject the ALJ's report and recommendation. Please note: If you choose an administrative hearing, the Department reserves the right to request that City Council impose the costs of the administrative hearing, per Saint Paul Legislative Code section 310.05(k).
