Upon arrival, Engine 14 found heavy fire and smoke conditions on the first and second floor. Car 5 arrived and assumed command. Building was a 2-story abandoned commercial building. Engine 14 quickly knocked down the fire on the first floor. Ladder 18 assumed roof division and started ventilation on the roof. Ladder 23 performed a primary search. Engine 23 secured a water supply for themselves and Engine 14, then backed up Engine 14 on fire attack. Command balanced the alarm and called for PD for traffic control. A Second alarm was called. A special alarm for 2 extra engines was called. Chief 3 was assigned Charlie Division. Chief 2 was assigned Safety. Ladder 22 was RIT. Squad 1 and Engine 10 performed fire attack from the Charlie Division. All searches negative. No injuries reported. Car 20 was called in from home for investigation. Squad 2 assisted Car 20. Media was on scene. Ladder 19 responded with the Air Trailer. Rehab set up by Car 50 and Ambulance 2. Car 50 FIT until transferred to Safety.
