### Water utility tech. Il sought to join water utility staff

The water utility is seeking a water utility tech. II. The role involves developing, maintaining, preserving, and archiving digital and physical engineering drawings and records. It develops and maintains drawings and other records related to engineering capital improvements.

#### Requirements

Two-years of experience as a water utility technician I (entry level field and office work including inspecting the installation, repair, and maintenance of water systems-technical, record maintenance, monitoring, and reporting experience) or equivalent AND

Twenty college semester credits including at least six-

teen semester credits of technical classes. Technical classes include math, engineering, GIS, CAD, public works administration, and technical/business writing. Technical/business writing limited to four semester credits.

Additional years of qualifying experience may be substituted, one year for two semester credits, to a maximum of three years for six semester credits.

No substitution of credits for experience.

Must possess and maintain a valid Minnesota Class D driver's license or equivalent out-of-state driver's license.

He was promoted to water


