An inspection was made of your building on September 21, 2022, in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. **A** reinspection will be made on September 29, 2022, at 1:30 pm.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- 1. Fence East exit from rear bar SPLC 34.08 (5), 34.32 (3) All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements. -The fence along the east exit from the rear bar is leaning due to debris from collapsed wall.
- 2. Roof above east exit from rear bar Permit required 2020 MSBC Chapter 1300.0120 Permits. Subpart 1. Required. An owner or authorized agent who intends to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert, or replace any gas, mechanical, electrical, plumbing system, or other equipment, the installation of which is regulated by the code; or cause any such work to be done, shall first make application to the building official and obtain the required permit. -Per senior building inspector a roof has been built above the built above the east exit from the rear bar without a permit. Have a licensed contractor apply for a permit and have the work inspected and approved.
