## **ESTIMATE DETAILS**

Investing in the neighborhood - Copy: After all walls and ceilings are removed as needed to provide access for plumbing we will remove and dispose of all of the waste and vent piping for two bathrooms and two kitchen sinks. Then furnish and install new waste, vent and water supply for two bathrooms one kitchen sink on the main floor, and one laundry room on the second floor. Install customer supplied shower on the main floor. Includes installation of customer supplied pressure balanced faucets. Furnish and install new 1 inch main water distribution set the meter 12 inches above finish floor includes one new frostproof outside faucet. After all the finished surfaces are in, we will return and set one kitchen sink, two toilets, two vanities, includes faucets. All fixtures and faucets supplied by the home owner. Estimate does include all new emergency shut off valves and or isolation valves as needed for complete control of the water.

Remove and dispose of all the existing galvanized and black iron gas pipe. Furnish and install new gas Main from one of the meters capping off the other meter. Furnish and install a new gas manifold. One new gas line for the furnace, when the gas line for the water heater, and one new gas line for the stove. Includes air test and inspection of the air test. After test is approved we will connect all gas fixtures start up and test for operations.

Furnish and install one new 50 gallon power vented water heater includes new venting to the outside. Start up and test for operations.
