The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **September 13**, **2022** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. SPLC 34.23 **CONDEMNATION:** The basement bedroom is condemned as unsafe or dangerous. It constitutes a condition of material endangerment to occupants and emergency personnel.

BASEMENT BEDROOM IS CONDEMNED DUE TO HAVING NO EGRESS WINDOWS. IMMEDIATELY REMOVE THE MATTRESSES AND BED FRAME AND DISCONTINUE USE AS A SLEEPING AREA.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on **September 20, 2022 at 9:00 AM**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
