Dear Applicant:

The Department of Safety and Inspections will recommend denial of the Second Hand Dealer (Comp/Elec) license application submitted by Angkor Phone Trader, LLC d/b/a Angkor Trader for the premises located at 422 University Avenue West, Unit 4 in Saint Paul. The recommendation is based on the following information:

On August 16, 2022, the Department of Safety and Inspections (DSI) received your application for a Second Hand Dealer (Comp/Elec) License. On August 30, 2022, you were sent an email confirming receipt of your application and letting you know that in order for DSI to continue processing your application you would need to submit the following information:

- 1. A copy of your signed lease
- 2. Business information (including hours of operation for each day of the week and the address of where your business records will be kept)

On December 21, 2022, you were sent a second (2<sup>nd</sup>) email from DSI with an attached letter regarding the application you submitted. The letter stated that your application was still "Pending" and that it would remain in this status until you submitted the required information. The letter set the deadline for the requested information as January 31, 2023.

This letter was also sent by U.S. Mail to 422 University Avenue West, #4, St. Paul, MN 55103 (the business/mail-to address you indicated on your application). On January 17, 2023, the Department of Safety and Inspections received the letter they mailed to that address "Return to Sender – Attempted – Not Known-Unable to Forward."

You have four (4) options on how to proceed:

- 1. If I have not heard from you by **April 10, 2023**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council Agenda for approval of the proposed remedy.
- 2. Submit the information requested to the Department of Safety and Inspections (DSI) located at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **April 10, 2023.** A self-addressed envelope is enclosed for your convenience. Submission of the required forms will be considered a waiver of the hearing to which you are entitled.
- 3. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **April 10, 2023.** The matter will then be scheduled before the City Council to determine whether to deny your Second Hand Dealer (Comp/Elec) license. You will have an opportunity to appear before the City Council and make a statement on your own behalf.
- 4. You can withdraw your Second Hand Dealer (Comp/Elec) license application. Complete and return the attached <u>REQUEST TO WITHDRAW REQUEST FOR REFUND</u> form to the Department of Safety and Inspections (DSI), located at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101–1806 no later than **April 10, 2023**.

If you have not contacted me by April 10, 2023, I will assume that you do not contest the denial of your Second Hand Dealer (Comp/Elec) license. In that case, the matter will be placed on the next available City Council Consent Agenda for approval of the recommended penalty.
