The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 6:00 p.m. to 10:00 p.m. with a pre-event sound check at 3:00 p.m. on Saturdays, June 3, July 8 and August 12, 2023 for the Dual Citizen Brewing Outdoor Service Area- 725 Raymond Avenue Summer Concert Series. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA at 50 feet from any sound source on Saturdays, June 3, July 8 and August 12, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Saturdays, June 3, July 8 and August 12, 2023.
