Case Narrative

The fire department was called to the report of a fire in a dwelling. Firefighters arrived and found the upper floor of the residence with heavy smoke and fire showing. Firefighters extinguished the fire and conducted overhaul.

While units were responding to the scene, dispatch notified crews of a male party with a knife in the yard of the residence. Shortly after fire crews arrived, police had the subject in custody. The male party was having a mental illness issue and was transported by police to Regions Hospital for further evaluation.

Interview with the suspect in custody revealed that he took the black curtains that were filled with "entities" and placed them in the oven. He stated that he never turned the oven on, but it burst into flames. A short time later he exited the structure and was met by police.

Security cameras were present on the residence as well as neighboring houses. Homeowners daughter stated they are not sure if the camera works. But would notify us if they had footage.

Investigation found a 2 story multi-family residence that faced East. Heavy smoke was coming from the second floor. Heavy fire damage noted on the second floor with the bulk of the fire damage noted in the Kitchen of the second floor. After photographs were taken and interviews conducted, crews finished with clean up duties. A short time later, command was terminated and the scene was released.
