Permit may be required. FOUND THE SOFFITS AND EAVES AROUND THE 2ND STORY OF THE HOUSE IN DISREPAIR. PLEASE REPAIR OR REPLACE THE MISSING OR FALLING SECTIONS OF THE EAVES AND SOFFITS FROM AROUND THE PROPERTY.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on **August 22, 2022**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
